

## MENTEE WAIVER AND RELEASE AGREEMENT AND PHOTO CONSENT

Mentee conveys to OSG U-Turn Mentor Program all right, title, and interest in any and all photographs, images, video, or audio recordings of Mentee or Mentee's likeness or voice made by OSG U-Turn Mentor Program in connection with his/her participation in the Program (collectively, "Media"). Mentee acknowledges that OSG U-Turn Mentor Program may freely use such Media on its Website and in connection with marketing of the Program.

This Agreement is intended to be as broad and inclusive as permitted by the laws of the State of South Carolina and shall be governed by and interpreted in accordance with the laws of the State of South Carolina.
