Grounds for a fine or immediate expulsion and forfeiture of dues at the sole discretion of the President of Target Properties, Inc.;

- A. Firing into the air. Firing from off the firing line or firing over the tops of berms or at objects on top of or near the tops of berms. *This activity can kill someone miles away.*
 - B. **Shooting at targets short of the berms into the ground**, such as at cans, or non-approved targets. This could cause very dangerous ricochets over the berms. You may not use your own target stands or metal targets. **Make sure the dirt berm is not more than 5 feet behind your target. NO MAGNUM ROUNDS ON METAL TARGETS!**
 - C. Destruction or vandalization of Club property of any sort.
 - D. **Handling or touching unencased or unholstered weapons loaded or unloaded;(A) in the parking lot (B) off the firing line (C) while a fellow shooter is down range (D) from one firing line to another (such as from pistol range to PPC range).**
 - E. **Shooting buckshot, rifle center fire rounds or slugs anywhere except on the 100 yard Rifle Range. RE-READ THIS!**
 - F. Littering, especially cigarette butts and shot gun hulls. WEAR SAFETY GLASSES.
 - G. **Use of .50 cal., TRACER**, green tip, or armor piercing ammo. If I use any such rounds, I agree to forfeit the weapon I used to fire these rounds and forfeit my membership.
 - H. **Possession or use of exploding targets, shotgun buzz bombs or flares.** RE-READ THIS!
 - I. Fishing is catch and release only. You MAY NOT use barbed hooks.
 - J. Minors or guests shooting unattended by yourself or without safety glasses.
 - K. Pointing a gun (loaded or unloaded) at anyone, including yourself.
 - L. Allowing your NRA membership to expire (you ought to be a life member).
 - M. **Failing to rigorously enforce these rules when you observe violations. RE-READ!**
 - N. Drinking alcohol prior to or during shooting. WEAR SAFETY GLASSES!
 - O. Failure to display your I.D or Club T-Shirt or club hat. In your pocket does not count.
 - P. **Ungentlemanly conduct. No cursing, foul language or racial slurs.**
 - Q. **No weapons may arrive in the parking lot unless encased and unloaded or holstered.**
 - R. **No shooting rifle rounds except on rifle range. RE-READ this sentence!**
 - S. ***All weapons must be unloaded with action open with chamber flag inserted and rifles racked before going down range.* RE-READ this sentence!**
 - T. **No shooting over berms or off the firing line or at any target not directly in front of and close to a berm.**
 - U. No fires, except in designated areas. **ALWAYS WEAR SAFETY GLASSES!**
 - V. No touching anyone else's gun or his or her's person without permission.
 - W. **No touching any gun after a cease fire order is given.**
 - X. **Possession of any weapon chambered for a rifle cartridge or slug or buckshot on any range except the rifle range.**
 - XX. No guest can visit more than once, total.
- SHOTGUN RANGE**
- Y. DO NOT load more than one round at a time, except when shooting doubles.
 - Z. DO NOT use anything heavier than 7½ shot. **Wear safety glasses!**
 - AA. ALL actions open except when on station ready to fire.

1. Enclose renewal check for **\$300.00** and a new picture for your I.D if needed. Make check payable to **Target Properties, Inc. POB 5877, HHI, SC 29938.**

2. Initial each paragraphs A-Z. This is a test to see if you really bothered to read these rules. Stupid members are not allowed to rejoin.

3. **I agree that the key to the range and ID remain the property of Target Properties, Inc. d/b/a Dos Lupes and if I fail or refuse to return these or any other property of Target Properties, Inc., I will pay collection fees, attorney fees, filing fees and service of process fees in a lawsuit against me. I agree that it is my responsibility to return the club key and ID to Target Properties, Inc., POB 5877, HHI, SC 29938 via registered/certified mail ONLY. I agree that \$1,000.00 is a reasonable amount for such attorney fees. I hereby waive a trial by jury.**

4. I swear under penalty of perjury (up to one year in jail) that my NRA number is correct and valid and that I have not let my NRA membership lapse.

What is best about the club shirts is that if you wear your club t-shirt you don't need to wear your ID.

1. What range(s) can I shoot a pistol chambered for a center fire rifle round on?
2. What range(s) can I shoot slugs on?
3. What range(s) can I shoot buckshot on?
4. What range I can shoot a center fire rifle on?
5. Under what circumstances can I take my weapon out of its case or holster?
6. If I touch my weapon while people are downrange, do you agree to pay a fine of \$100 on the spot? Do you think this is fair?
7. What would be the proper procedure to show someone your gun in the parking lot?
8. What should I do before I go downrange?
9. Where can I go clean my weapon after firing it?

13. Must anyone on the firing line use ear and eye protection or only shooters?
14. May I shoot without hearing or eye protection on the shotgun range?
15. What is the only proper way to carry any weapons from your car to one of the firing lines?
16. May I use my own target stands without written permission?
17. May I shoot into the ground or at something short of the berm?
18. May I shoot a rifle on the pistol range so long as it is chambered in a pistol caliber?
19. How many times can I bring my buddy out as my guest?
20. If I will not promptly pay my dues and do not timely return the club's key and ID by registered mail, what can I expect to happen to me? Is this fair?
21. When must club ID be worn on club grounds (if not wearing a club t-shirt)?
22. Is it ok to leave the gates unlocked if I am only going to shoot a few rounds?
23. If I see someone on the firing line without safety glasses what is my obligation?
24. If I see someone on club grounds not wearing a club shirt OR ID what is my obligation?
25. If I see someone behaving in an unsafe or rude way what is my obligation?
