This application is for the installation of reinforced concrete pipe within the City of La Marque Street Right of Way in accordance with the City Ordinance Sec. 56-30.

The City of La Marque will install culverts that are replacements for existing culverts on residential properties only.

New Residential / New Commercial / or Extensions to existing culverts must be installed by the contractor or property owner's expense. Inspection of contractor installed culverts is required. 3. Plan review fees must be paid when application is submitted.
4. Culvert application submitted with required documents, if applicable
5. Contractors MUST be registered with the City of La Marque

The City's average plan review time is 3-5 business days.

Inspection requests must be made by 4:00pm Monday – Thursday and by 11:00am on Fridays

Inspections are scheduled for the next available inspection slot based on our schedule when request received, most inspections will be performed within 48 hours of a request.

Fees for replacing existing or damaged culverts by the Public Works Department: \$55.00 per sq. ft.  
(if owner is 65 YOA or older: \$40.00 per sq. ft.)

Driveway shall conform to COLM Design Criteria Manual
