RELEASE, ASSUMPTION OF RISK, WAIVER & INDEMNIFICATION



WITNESS THIS AGREEMENT this _____ day of _____, 20____, by and between Cayuse Kids (CK) Saddle Club, hereinafter referred to as ORGANIZER and _____ hereinafter referred to as RIDER.

Rider, Rider’s heirs, assigns, and representatives, hereby agree as follows:

1. RIDER AGREES TO ASSUME ANY AND ALL RISKS INVOLVED IN OR ARISING FROM RIDER’S VOLUNTARY PARTICIPATION IN ANY ACTIVITY CONDUCTED BY THE ORGANIZER, INCLUDING, BUT NOT LIMITED TO RISKS OF DEATH, BODILY INJURY, PROPERTY DAMAGE, FALLS, KICKS, BITES, BOLTS, COLLISIONS WITH VEHICLES, OTHER HORSES OR STATIONARY OBJECTS, FIRE, EXPLOSION, LIMITED EMERGENCY MEDICAL CARE AVAILABILITY, OR THE NEGLIGENCE OR DELIBERATE ACT OF ANY OTHER PERSON. Rider acknowledges that equines, by their very nature are unpredictable and subject to animal whim. Rider assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising there from. Rider agrees to abide by and follow Organizer’s rules and regulations. Rider further acknowledges that the behavior of any animal is contingent to some extent upon the ability of Rider. Rider assumes all risks therefore and warrants that Rider has the requisite abilities to safely participate in the Activity.

WARNING - All Activities involving HORSES, donkey, mules or ponies (equines) have inherent risks for Participants/Riders. Idaho State Law protects operators, owners, trainers, promoters and others from liability for injuries which are the result of an equine animals’ behavior. RIDE AT YOUR OWN RISK.

2. Rider agrees to hold harmless, indemnify and defend Organizer, landowners, volunteers, service providers, vendors, CK members and officers, officials and sponsors against, and hold harmless from, any and all claims, demands, causes of action, damages, judgments, orders, costs or expenses, including attorney’s fees, whether actually incurred or not, which may in any way arise from or be in any way connected with Rider’s participation, even if the harm resulted directly or indirectly from the negligence of the Organizer or the Activity, officials, CK members or officers, landowners, volunteers, service providers, vendors or sponsors.

3. In the event Rider is using Rider’s own equine, or equine(s) not owned by Rider, Rider warrants said equine(s) shall be free from infection, contagious or transmittable diseases. Organizer reserves the right to refuse access or use of any equine to participate in any Activity if same does not appear to Organizer to be in good health, or is deemed dangerous or undesirable.

4. Rider agrees to assume all liability and responsibility for any accidents, injury or damages sustained or caused by Rider, Rider’s helpers, stock or equipment and to expressly assume all risks of harm to Rider and/or horses including harm resulting from the negligence of the Organizer, or the Activity, officials, CK members or officers, landowners, volunteers, service providers, vendors or sponsors.

5. Rider agrees to waive the protection of any applicable statutes in this jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing said release.

6. Riders under the age of 18 years must be accompanied by parent or legal guardian and have obtained signature of parent or legal guardian prior to participation. If I am a parent or guardian of a youth Rider, I consent to the child’s participation and agree to all of the above provisions and agree to assume all of the obligations of this Release on the child’s behalf.

COVID-19 RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of the above-named ("Participant") being allowed to participate and compete in 2020 Cayuse Kids Saddle Club events, we, the Participant, and the UNDERSIGNED parent(s) or legal guardian of the Participant, on behalf of the Participant, and for ourselves, our personal representatives, heirs, spouse, parents, siblings, and children, do hereby:

1. ACKNOWLEDGE THE EXPRESS ASSUMPTION OF RISK: PARTICIPANT hereby acknowledges and understands that the World Health Organization has declared COVID-19 a worldwide pandemic. COVID-19 is extremely contagious and spreads mainly from person-to-person contact. Based on currently available information and clinical expertise, older adults and people of any age who have serious underlying medical conditions may have a higher risk for severe illness from COVID-19. There have been recommended guidelines and preventative measures put in place to reduce the spread of COVID-19; however, it CANNOT GUARANTEE that PARTICIPANT will not become exposed to or infected with COVID-19, despite reasonable efforts to mitigate such dangers. Furthermore, the Activities could increase PARTICIPANT'S risk of contracting COVID-19. By signing this Agreement, PARTICIPANT acknowledges the extremely contagious nature of COVID-19 and voluntarily assumes the risk that PARTICIPANT may be exposed to or infected with COVID-19 from the Activities, and that such exposure or infection may involve the RISK OF SERIOUS INJURY, ILLNESS, PERMANENT DISABILITY AND/OR DEATH. PARTICIPANT understands that the risk of becoming exposed to or infected with COVID-19 by PARTICIPANT'S participation in the Activities may result from the actions, omissions, or negligence of others and/or PARTICIPANT, including, but not limited to, the RELEASEES (as defined below). PARTICIPANT hereby expressly assumes all such risks and dangers whether presently known or unknown.
2. RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the Cayuse Kids Saddle Club, any CK committee, any stock contractor, any event sponsors and/or CK saddle club grounds landowners and each of them and their officers, directors, trustees, managers, agents and employees (all of whom are collectively referred to herein as "Releasees") from any and all liability to the Participant, the undersigned, and their personal representatives, assigns, heirs, parents, legal guardians, siblings, and children, and any claims or demands therefore, on account of the Participant's or the undersigned's injury, illness, disease or death from the COVID-19 coronavirus, which occurs as a result of the Participant's or any of the undersigned's entrance onto the CK saddle club grounds and/or participation as a contestant, assistant, official or otherwise in any event, whether such injury, sickness, disease or death is caused by the negligence or other wrongful conduct of, strict liability or otherwise by, one or more of the Releasees or any contestants, participants, spectators or other individuals at the CK saddle club grounds.
3. AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and each of them from any liability, damage or loss (including, but not limited to, attorneys' fees and other defense costs) one or more of them may suffer or incur arising out of or related to the Participant's or any of the undersigned's entry onto the CK saddle club grounds and/or participation in any events, whether such claim is based on one or more of the Releasees' negligence, breach of contract or warranty, strict liability or other legal theory.
4. UNDERSTAND that Participant's and the undersigned's entry onto the CK saddle club grounds and/or participation in events during the COVID-19 pandemic contains DANGER AND RISK OF ILLNESS, DISEASE, INJURY OR DEATH TO PARTICIPANT and the undersigned, that COVID-19 is highly contagious, and that there is INHERENT DANGER in COVID-19 which the Participant and each of the undersigned appreciate and voluntarily assume because we choose to do so. WE EACH VOLUNTARILY ELECT TO ASSUME AND ACCEPT ALL RISKS inherent in COVID-19.
5. AGREE to comply with all federal, state and local laws and regulations and all security policies and procedures of the CK saddle club relating to COVID-19. We each understand that the Participant may be denied entrance to the CK saddle club grounds and not allowed to participate or continue to participate in the event based on any medical check-in requirements and continuing medical requirements during the duration of the event. The undersigned agree that in the event any portion of this document is held to be invalid, the balance shall, notwithstanding, continue in full legal force and effect to the greatest extent possible under applicable law. The parents or guardian of the Participant agree that by signing below they are in addition to binding themselves, binding the Participant to the maximum extent permitted by applicable law.

WE HAVE READ THIS RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE, AND INTEND THIS TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY APPLICABLE LAW.
