

Sage Range BOD Meeting Minutes

Date: Wednesday Sep 19, 2018

The Meeting was called to order at 6:00 PM by Mike Cooper.

Old Business:

- The Aug BOD minutes were reviewed, Mike motioned, Richard seconded that the minutes be approved. Motion carried.
- Election. Currently 4 people are nominated and have accepted. Gabby and Chelsea were nominated at the meeting. Election will run from now to next board meeting. The following will be on the ballot.

- Sharon will get with Bill to update the bylaws to capture the changes voted on by the BOD to change number of members on the BOD.
- Ammo checked and have 500 rounds of 9 mm. 500 at Sage Range. WOT may need to purchase 9 mm of ammo
- Road repair is still in work.
- Cleanup day will be at end of Oct.
- Family Day grant. Still being worked.
- The 4 grants planned for submission from the range were identified. Deadline Oct 24. The Women and Children shoot for free will be divided into 3 grants (USPSA, Shotgun, 22 shoot)
- Mike has new conex keys. Cage has same key.
- Erik provided a write up regarding a member running for Ridgecrest City Council. It was not an endorsement but information about the candidate. A motion was made by Mike to send out to Sage Range email list. Gabby seconded. Motion carried with 1 abstention.
- Trap machines are doing well. On 29 September, a 50/50 shoot will be held. Request that the shotgun fee be changed to \$5 for members and \$6 for non-members. Concern that \$6 for non-members will be hard to execute. Put off vote to next meeting. Need clarification on what is covered for women and children.

New business:

- We have 225 keys. Last year 25 keys were sold as the second key. A suggestion was made to put combination padlock on instead of keyed lock. Discussion was that control of access would be difficult if that was done. Mike motioned to change to a combination padlock. A second was not made.
- Mike will buy keys for next year.
- A suggestion was made that the remainder of the keys be prorated to \$10 for the rest of the year until supply runs out. Mike motioned. Gabby seconded. Motion carried.
- Chelsea asked about a shotgun patterning board. Need to ask Bill.
- Ask Tiana and Chrissy to come to the next meeting to discuss having a class for range members.
- Dan will put up the pricing for the new prorated keys on the website
- Need to move the quad to the lower conex. Mike will move it.
- Richard is looking at putting signs around the range perimeter to identify as a Shooting Range.
- Stands are being worked. Put in USPSA conex. Put the used one out for the others to use. Look at Sage Range t-shirts. Richard will look into. Need to get a good digital copy of the logo.
- Mike motioned, Sharon seconded that the meeting be adjourned. Motion carried.
