QUALIFICATIONS

JUDGE EXECUTIVE

Judge Executive receives admin reports from directors utilizing county funds (animal shelter, public works, tech services, parks/buildings, & grounds/golf courses) and enforces county ordinances, court orders, and resolutions of all contracts entered into by the fiscal court. (4 years, \$150,000 yr)

Must be at least 24 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years, and in the district for at least 1 year prior to the election.

COUNTY CLERK

County Clerk serves as chair of the county board of elections, maintains records for voter registration, auto licensing, real estate sales, liens, deeds, powers of attorney, wills, affidavits, leases, maps, surveys, plats, and business registrations. (4 years, \$150,000 yr)

Must pass a written examination on the duties of the office.

Must be at least 21 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years, and in the district for at least 1 year prior to the election.

SHERIFF

Sheriff collects taxes for distribution to agencies, assists with elections, courtroom duties, and law enforcement by managing the flow of prisoners between jail, court, and state prison facilities (4 years, \$150,000 yr)

Must be at least 24 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years, and in the district for at least 1 year prior to the election.

CORONER

Coroners determine the cause and manner of deaths to provide answers for the deceased and their family. (4 years, \$40,000 yr)

Must be at least 24 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years and in the district for at least 1 year prior to the election.

PROPERTY VALUATION ADMINISTRATOR (PVA)

PVA assessing all property in the county and keeps records of all assessments and appraisals. (4 years, \$154,000 yr)

Must pass a written examination covering the duties of the office.

Must be at least 24 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years and in the district for at least 1 year prior to the election.

SURVEYOR

Survey property and determining boundary lines. (4 years, \$30.42/hr)

Must hold a Kentucky license as a professional surveyor.

Must be at least 24 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years and in the district for at least 1 year prior to the election.

JAILER

Jailers are responsible for the custody and care of inmates by ensuring humane treatment by providing clean and safe condition for prisoners.

(4 years, \$150,000 yr)

Must be at least 24 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years and in the district for at least 1 year prior to the election.

CAMPBELL COUNTY
JUSTICE OF THE PEACE
(DISTRICTS 1-3)

Justice of the Peace perform marriage ceremonies and the acceptance of applications for notaries public.
(4 years, salary varies)

Must be at least 24 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years and in the district they are running in for at least 1 year prior to the election.

CAMPBELL COUNTY
CONSTABLE
(DISTRICTS 1-3)

County Constables serve subpoenas and warrants, sell property to enforce liens, and support animal control. (4 years, \$\$60 per service plus a \$10 fiscal court fee, for a total of \$70.)

Must be at least 24 years of age, a citizen of Kentucky, and have lived in Kentucky for at least 2 years and in the district they are running in for at least 1 year prior to the election.

SOIL AND WATER
CONSERVATION DISTRICT
SUPERVISOR

Soil and Water Conservation Supervisors protect and manage the counties renewable and natural resources. (4 years, \$4600 yr)

Must be a resident of the district for which they are running.

CAMPBELL COUNTY
COMMISSIONERS
(DISTRICTS 1-3)

County Commissioners act as a legislative body for the county, voting on all business matters at meetings of the fiscal court, normally scheduled twice a month.

(4 years, \$45,000 yr)

Must be at least 24 years of age, a citizen of Kentucky, and having lived in Kentucky for at least 2 years and in the district they are running in for at least 1 year prior to the election.

CITY COUNCIL SEATS

City Council members attend regular meetings to vote on city business and hear resident concerns while also serving on various committees or boards including finance, park/recreation, planning and zoning.

(2 years, salary varies)

Being at least 18 years of age, a resident of the city for at least one year prior to election, and a qualified voter.

MAYORS

The Mayor is the chief executive officer for the city and presides over council meetings, oversees local operations, manages public services while engaging with residents. (4 years, salary varies)

Being at least 21 years of age, a resident of the city for at least one year prior to the election, and a qualified voter.

SCHOOL BOARDS

School board members represent the interest of all citizens regarding the education of students. Attending school board meetings to vote on school policies, plans, and financial matters.

(4 years, salary varies)

Being at least 24 years of age, a resident of Kentucky for at least 3 years prior to the election, a voter in the district where they are seeking election, and have a high school diploma or a GED certificate. A candidate cannot hold any federal, state, county, or local office at the time of election, and cannot be related to anyone employed by the school district.
