Rules and Regulations

1. Anyone desiring the use of the Park facilities shall secure a permit from the Authority office in advance. **No deposits shall be refunded.**
2. Anyone obtaining a permit (organizational individual) for the Park will be responsible for the Park and must be present at the affair from start to finish.
3. The Authority reserves the right to refuse, at its discretion, any permit requested, to revoke any permit already issued or to close the Park at any time, if in its opinion it is in the best interests of the Authority.
4. The Reservoir Park shall be open to the public from May 1 to October 1.
5. Hours of operation are 9:00 AM to 9:00 PM. Times for opening and closing must be followed according to the times listed on the permit. Opening and closing times may be changed with at least one (1) week's prior notice.
6. All users of the Park agree to be held responsible for damage to property of the Authority and the satisfactory cleaning up of the premises. Any expense incurred by the Authority in the repairing of damaged property or the clean-up of debris shall be billed to and paid by the individual or organization/responsible individual at the discretion of the Authority. **Any decorations (ie. Balloons, streamers) need to be removed at the end of the event or an additional clean-up cost, including Authority time/disposal will be assessed. No use of tacks, staples or the like are permitted of any kind at any time and use may result in damage fees.**
7. The Authority assumes no responsibility for injury or death of anyone which occurs on the property of the Authority. No trespassing, swimming or fishing in the mine hole is permitted. Violators will be prosecuted.
8. The Rules and Regulations governing the use of the Reservoir Park must be followed. Violations shall result in the denial of future use of the park, and may, at the discretion of the Authority, result in criminal prosecution.
10. Firearms, explosive devices and fireworks are prohibited and violators will be prosecuted.
11. A copy of this permit will be given to the individual or organization applying for the permit and shall be made available upon the request of the Park caretaker.
