



INDOOR WORLD LLC WAIVER FORM

READ CAREFULLY – THIS AFFECTS YOUR LEGAL RIGHTS

In exchange for participation in the activity of Indoor Playground organized by Indoor World LLC, of 4670 Merchants Park Circle, Suite 660, Collierville, Tennessee, 38017 and/or use of the property, facilities, and services of Indoor World LLC, I agree for myself and for the members of my family, to the following:

1. **AGREEMENT TO FOLLOW DIRECTIONS.** I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Indoor World LLC, or the employees, representatives, or agents of Indoor World LLC.
2. **ASSUMPTION OF THE RISKS AND RELEASE.** I recognize that there are certain inherent risks associated with the above-described activity in an indoor playground such as slides, ball pits, trampoline, crawl tubes and more. I assume full responsibility for personal injury to myself and (if applicable) my family's use of or presence upon the facilities of Indoor World LLC, whether caused by the fault of myself, my family, Indoor World LLC or other third parties.
3. **INDEMNIFICATION.** I agree to indemnify and defend Indoor World LLC against all claims, causes of action, damages, judgments, costs, or expenses, including attorney fees and other litigation costs, which may in any way

arise from my or my family's use of or presence upon the facilities of Indoor World LLC.

4. FEES. I agree to pay for all damages to the facilities of Indoor World LLC caused by any negligent, reckless, or willful actions by me or my family.
5. CONSENT. I consent in the activity of Indoor Playground and agree on behalf of the minor to all the terms and conditions of this Agreement. By signing this Release of Liability, I represent that I have legal authority, custody, guardian, or permission over the minor(s) present with me.
6. APPLICABLE LAW. Any legal or equitable claim that may arise from participation in the above shall be resolved under Tennessee law.
7. NO DURESS. I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing.
8. ENFORCEABILITY. The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement or of any other applications of such provision and such invalid or unenforceable provision shall be deemed not to be a part of this Agreement.
