This contract states that for any reason you are no longer wanting to keep the puppy, that she/he be returned to us. This puppy is sold as a pet and shall at no point be used as a breeding Stud.

We strive for a happy well-adjusted puppy, our puppies have been house trained, car trained and kennel trained to ensure an easy transition into your home. Our puppies are all feed on a raw diet, with fruits and vegetables added as treats. We would like to make sure our puppies continue a healthy natural diet, for the remained of their lives. If you have any questions on a Raw diet, please let me know, I am happy to help you. The Puppy has been registered under Castleguard with CKC, under the breeder name.

The puppies have been to the vet, and have a clean bill of health at the time of sale, they are also all microchipped, with the number on the registration papers. The puppies have been vaccinated for Parvo and distemper. Please ensure they are not exposed to high dog areas until 4 to 5 months of age, if you are going to vaccinate the puppy, PLEASE make sure the vaccinations are done one at a time, with at least a 3 to 4 month waiting period in between the vaccinations. As the Border terrier is very prone to vaccinosis (reactions from over vaccinations).

Your puppy is registered with CKC, if you are interested in getting into dog sports or showing, please let me know I would be happy to help you. There are lots of fun games for your puppy to enjoy, leerbug.com has a ton of training info and help.

And now for the fine print:

- The Buyer shall notify the Breeder immediately if the dog cannot be kept by the Buyer.
- The dog shall not be sold, transferred, or given to any individual or to any retail or wholesale establishment for the purpose of sale or resale to the public or to any research institution where medical experimentation or other practices take place.
- The Buyer and Breeder agree to keep each other informed of their current addresses.
- The Buyer agrees that it is the Buyer's responsibility to accept the dog as described. The Breeder has provided, and the Buyer has acknowledged a full disclosure of the health, habits, and temperament of the dog. The dog's health records will be supplied at time of purchase.
- The Buyer shall have 3 months from the date of this Contract to return the dog for a full refund of the purchase price.
- After 1 month and for the life of the dog, the Buyer may return the dog to the Breeder at any time and for any reason.
- The dog in the event the dog is returned The Buyer agrees to sign the necessary papers to return the Breeder as sole owner of the Dog
- Buyer shall keep the dog as a household pet and provide the dog with food, fresh water, shelter, affection, and medical care upon sickness, disease, or injury. Humane care and maintenance in accordance with all current and future state, county, and municipal laws and ordinances where the Buyer resides. A fully fenced yard or other humane means of exercise. The dog shall not be kept chained or constantly outdoors. A collar and identification tag and/or microchip. Never permit the dog to roam unattended. Shall not alter the dog before one year of age.
