

## WAVIER AND RELEASE OF LIABILITY

In consideration of the risk of injury while participating in AWYSE Football \_\_\_\_\_ (Age Division) League & for the right to participate in season Activity, I hereby, for myself, my heirs, executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this wavier and release of liability and hereby waive any and all rights, claims or causes of \_\_\_\_\_ (League name), located at \_\_\_\_\_ (League address), their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors, and assigns, for any physical and psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, or death due to a pandemic such as Covid-19 that I may suffer as a direct result of my participation in the aforementioned Activity, including traveling to and from an event related to this Activity.

I (INCLUDING PARTICIPANTS, PARENTS & ALL FAMILY MEMBERS) AM VOLUNTARILY PARTICIPATING IN THE AFOREMENTIONED ACTIVITY AND I AM PARTICIPATING IN THE ACTIVITY ENTIRELY AT MY OWN RISK. I AM AWARE OF THE RISKS ASSOCIATED WITH TRAVELING TO AND FROM AS WELL AS PARTICIPATING IN THIS ACTIVITY, WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO, PHYSICAL OR PSYCHOLOGICAL INJURY, PAIN, SUFFEREING, ILLNESS, DISFIGUREMENT, TEMPORARY OR PERMANENT DISABILITY (INCLUDING PARALYSIS), ECONOMIC OR EMOTIONAL LOSS, AND DEATH DUE TO A PANDEMIC SUCH AS COVID-19. I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS "WAVIER AND RELEASE" AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. This Agreement was entered into at arm's length, without duress or coercion, and is to be interrupted as an agreement between two parties of equal bargaining strength. In the event that any provisions contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, conditions, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect, so long as the clause severed does not affect the intent of the parties. If a court should find that any provisions of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, constructed, and enforced as so limited.
