Sub: Application for Letter of permission for State Homoeopathic Medical College, Paraspani, Godda Pathargama, Jharkhand for Under Graduate Course (BHMS) with admission capacity of 63 seats (including 13 seats of EWS quota) during the academic year 2022-2023-reg.

Sir/Madam,

The Medical Assessment and Rating Board has received online application (Part-1) seeking permission for student intake in (Under Graduate (BHMS) course with intake capacity of 63 seats including 13 EWS seats for the academic year 2022-23.

- 2. As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MARBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform that Part-1 proforma and all the relevant documents submitted by your college in were examined as per the existing regulations.
- 3. On scrutiny and careful consideration of your documents and further observations of the Board, College was given a chance for hearing on 27/10/2022. As per the discussion with the Principal, College agreed to appoint required staff in a time bound manner.
- 4. After considering the provisions of NCH Act, 2020 and its relevant regulations, conditional permission of the Medical Assessment and Rating Board is granted to State Homoeopathic Medical College, Paraspani, Godda Pathargama, Jharkhand with admission intake capacity of 63 seats (including 13 seats of EWS quota) for BHMS Course for the academic year 2022-23. The Principal is directed to fulfill all the deficiencies within three months and an undertaking from the controlling authority of the college may be submitted to the Medical Assessment Board within a period of one week.
- 5. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed only.
- 6. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. It is further informed that, minimum 15% seats of permitted intake capacity of BHMS course shall be treated as All India Quota. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed.
- 7. The counselling for seats under All India quota shall be conducted by respective counselling Authority of State/ UT Government as designated by the Central Government and counselling for the

remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counselling of seats under All India Quota shall be conducted by Central Government.

- 8. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed
- 9. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
