Through partnerships with schools, employers, industry associations, and community organizations, students participated in career expos, industry conferences, facility tours, workforce workshops, employer presentations, and interactive career exploration activities across skilled trades, manufacturing, energy, construction, maritime, transportation, STEM, and technology. These experiences connected students directly with professionals and real-world workplaces, helping them make more informed education and career decisions while strengthening the future workforce pipeline.

This One's for the Gals developed and distributed career awareness resources designed to introduce students to careers they may never have known existed. Educational materials, including children's books and career exploration resources, were created to reinforce workforce engagement experiences, increase career awareness, and provide students, educators, and families with age-appropriate information about careers in skilled trades, manufacturing, energy, construction, transportation, maritime, STEM, and technology.

This One's for the Gals developed and strengthened partnerships with schools, employers, industry associations, and community organizations to expand career awareness opportunities for students.
