Payment Requirements

However, if you are successful in the New Mexico Draw and/or a hunt is booked the \$166.00 fee will be applied to the hunt cost. If it is an Antlerless Hunt L&M Outfitter's requires a \$100.00 per person administrative fee to be paid at the time this contract is signed, This fee is non refundable, however, if a hunt is booked the \$100,00 fee will be applied to the hunt cost.

50% payment is due at the time the New Mexico State Draw results are released. Remaining balance must be paid in full 30 days prior to Activity. Payments made in the form of Cashier's Check, Money Order or Personal Check payable to L&M Outfitter's LLC
