To Bahamas, Bermuda, Caribbean (Eastern, Southern, Western), Mexico. Cruise accommodation is provided in a lower deck, inside stateroom. Peak season sailings are not available. Peak season includes June through August sailings and all major holidays New Year's Day, Easter, Memorial Day, Thanksgiving and Christmas.
