Background

These claims were amplified through public statements and legal challenges, creating a contentious post-election environment.

Federal Agency Assessments

Federal agencies played a critical role in assessing election integrity. The FBI, led by Director Christopher Wray (a Trump appointee), stated on September 24, 2020, that there was no coordinated national voter fraud effort ([NBC News](#)). The Department of Homeland Security's Cybersecurity and Infrastructure Security Agency (DHS-CISA) declared on November 12, 2020, that the election was the "most secure in American history," with no evidence of deleted, changed, or compromised votes ([CISA](#)). The Department of Justice, under Attorney General William Barr, confirmed on December 1, 2020, no fraud on a scale to affect the outcome, despite earlier memos allowing pre-certification investigations ([AP News](#)). The U.S. Election Assistance Commission also found no evidence of widespread fraud ([Business Insider](#)).

Legal Challenges and Court Decisions

Approximately 50 postelection lawsuits, primarily filed by Trump and his allies, aimed to discount votes, block certification, or overturn results. All were unsuccessful. Key rejections included:

- U.S. District Court in Pennsylvania (Judge Matthew Brann, November 21, 2020), dismissing claims for lack of evidence ([Court Listener](#)).
- Michigan 3rd Judicial Circuit (Chief Justice Timothy Kenny, November 13, 2020), rejecting fraud allegations ([Democracy Docket](#)).
- U.S. Court of Appeals 3rd Circuit (Judge Stephanos Bibas, Trump appointee, November 27, 2020), affirming no fraud evidence ([CA3 Courts](#)).
- Wisconsin Supreme Court (Judge Brian Hagedorn, December 4, 2020), and the U.S. Supreme Court rejecting a Texas lawsuit on December 11, 2020 ([Supreme Court](#)).

These decisions underscore the lack of legal basis for rigging claims.

Expert and Official Statements

The Brennan Center for Justice, in a report dated December 10, 2020, concluded the election was secure, with voter fraud being extraordinarily rare and checks in place to protect integrity ([Brennan Center](#)). A survey by the Harvard Kennedy School's Electoral Integrity Project, involving nearly 800 election scholars, overwhelmingly rejected fraud claims, though noting issues like gerrymandering and misinformation ([Harvard Kennedy School](#)). Republican election officials, such as Gabriel Sterling (GA), Scott Schwab (KS), and Kim Wyman (WA), publicly debunked fraud accusations, with Sterling calling them hoaxes on November 9 and December 1, 2020 ([NY Times](#)).

Statistical Analysis of Fraud Claims

A study published in the Proceedings of the National Academy of Sciences on November 2, 2021, analyzed specific statistical claims of rigging, finding no evidence to support them. Key findings include:

- Charlie Kirk's claim about Biden winning fewer counties was not anomalous, reflecting Democratic vote concentration ([PNAS](#)).
- Claims of voting machine manipulation (e.g., Dominion machines) showed insignificant effects in regressions (Table 1, SI Appendix, section E).
- Alleged irregularities in absentee ballots and turnout in suspicious counties were statistically normal after adjustments (Table 2, Fig. 4A, 4B).

The study concluded all claims were either not facts or not anomalous, reinforcing the election's integrity ([PNAS](#)).

Partisan Divide and Public Perception

Despite the evidence, a partisan divide persists. The Center for Election Innovation & Research (CEIR) surveys, such as one from November 2021, found many Republican and Trump voters distrust the results, driven by disinformation ([CEIR Survey](#)). Gallup polls from October 2020 showed confidence in election accuracy, but with a widening partisan gap, with 34% very confident by 2022, up from 19% in 2020 ([Gallup](#)). This divide, while significant, does not indicate actual rigging but reflects perception challenges.

Bipartisan Rejections and Recommendations

Notably, 31 former Republican Congress members called Trump's claims unacceptable on November 9, 2020 ([The Hill](#)). Figures like Ben Ginsberg, Karl Rove, and Mitt Romney also debunked fraud claims ([Washington Post](#), [WSJ](#)). The Harvard report recommended reforms like the For the People Act (H.R.1, 2019) to restore confidence ([Harvard Kennedy School](#)).
