 - f. A forgivable loan, not a grant. A lien will be placed on the home.
 - g. Requirements: Must be current on your mortgage and property taxes; No income or credit requirements or limit.
 - h. After money is paid back to JACC, it returns to NRP funds and is not unrestricted funds.
