#### WHAT DOES FAIR HOUSING LOOK LIKE TODAY? Written By Danyell Barker

To become an agent you had to learn all about what fair housing is and how to avoid discrimination. The Fair Housing Act was adopted in 1968 to protect individuals from being discriminated against based on race, religion, sex, or national origin. Later in 1988 they added familial status and people with disabilities to the protected classes. Considering the original act was prompted by the American Civil Rights Movement, it often seems as though this is an outdated issue that surely couldn't exist nowadays, right? Wrong. It may not be as blatant as the "Whites only" signs that used to be advertised, but what exactly does it look like in today's transactions?

In the 2021 Profile of Home Buyers and Sellers, they reveal the answers from homeowners surveyed about their experiences in regards to fair housing. In the report 50% of Hispanic/Latino, 48% of Asian/Pacific Islander, and 46% of Black/African American home buyers reported they either witnessed or experienced being steered towards or away from certain neighborhoods. That is a staggering amount of clients still facing these issues.

Another common form of fair housing violation appears in "love letters" or honestly, "liability letters". These letters are written with the intent to appeal to a seller's emotions and appear more worthy of deserving a particular home over another buyer. Even if it just seems as harmless as saying they can't wait to see their kids run down the stairs on Christmas morning, that statement alone could consciously or unconsciously cause the seller to accept or reject their offer based on familial status or religion.

You have been blessed to be given a leadership position that allows you to help fight against this unfairness by providing equal service for all clients. The National Association of REALTORS® has declared April to be "Fair Housing Month" to continue to raise awareness of the ongoing discriminatory issues, even if they may appear differently than they did 54 years ago.
