- Negative fecal test (GIARDIA, OVA, and PARASITES) within 90 days of check in

Owner and Kennel hereby agree as follows:

- 1. Kennel shall exercise due and reasonable care to keep its premises sanitary and enclosed.
- 2. Owner understands and accepts that there is a known presence of potentially harmful or lethal pests in the area against which Kennel's enclosures are ineffective (including but not limited to the following: toads, ticks, centipedes, scorpions, mongoose, owls, etc.) and shall not hold or attempt to hold Kennel liable for any harm resulting to Pet from such Pests.
- 3. Owner shall pay the rate for boarding in effect on the date Owner's Pet is accepted for check in by Kennel. Owner shall pay all costs and charges for special services requested and for all veterinary and transportation costs for the pet/animal during the time said pet/animal is in care of Kennel. Any outstanding balances not paid within 30 days are subject to interest accruing at an annual rate of 18%, provide that, if less, a minimum fee in lieu of interest shall accrue at the rate of \$25 fee/month.
- 4. Owner understands and acknowledges that Owner shall be solely responsible for any and all acts of behavior of its Pet occurring during the term and time of this Agreement and specifically waives and agrees to release Kennel from any liability with respect to its Pet, or any and all damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals or property, or death or injury to any other animal caused by the Pet during the term of this Agreement, whether the Pet the Pet be on the premises of the Kennel or not.
- 5. Owner understands and accepts that in no event shall the liability of the Kennel exceed the sum of One Hundred Dollars (\$100.00) for any and all damages sustained or suffered by reason of the boarding of the Pet.
- 6. Owner represents that s/he is the sole owner of the Pet.
- 7. Owner specifically represents that the Pet has not previously shown signs of aggression towards other animals or people and further agrees to be fully responsible and liable for all acts or behavior of the Pet while in the care of Kennel.
- 8. Guests are charged for their date of arrival regardless of what time they check in. Check- out time is 10 a.m. Guests who depart after 10 a.m. will be charged for the departure day.
- 9. Upon approval of the staff, reservations will only be confirmed upon receipt of a completed and signed Agreement, the required veterinary records, and a <u>non-refundable</u> deposit of 50 percent of the estimated boarding fees, provided however that full amount of estimated boarding fees for Nov. and Dec. shall be non-refundable. The remaining fees are due at check-in time.
- 10. Kennel shall have, and is hereby granted, a lien on Owner's pet/animal(s) for any and all unpaid boarding and/or other charges resulting from the boarding of said pet animal(s) with Kennel. If owner fails to pay all charges and/or claim said pet/animal(s) within 3 days of scheduled pick-up, Kennel has the right to sell said pet/animal(s) or otherwise dispose if it/them, at its discretion. Owner agrees to pay at double the daily boarding rate for each day after scheduled pick-up.

18.	This Agreement contains the entire agreement between the parties, and all terms and conditions will be in effect for this and all future boarding at the Kennel. Any changes to this contract must be agreed to in writing by both parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, and assignees of the owner of the within named animal/s.
17.	Thank you for providing your pet's meals in serving-size, sealed zip-lock bags. This applies only to kibble. Canned or wet food that needs refrigeration does not need to be pre-bagged. Our rates include feeding breakfast and dinner. If you pet is on a special feeding schedule and needs more frequent meals, please let us know when you make your reservation. There is an additional fee for special meal schedules.
16.	Any controversy or claim arising out of or relating to this Agreement shall be settled by arbitration in accordance with the rules of the American Arbitration Association in Honolulu Hawaii. The arbitrator shall, as part of his award, determine an award to the prevailing party of the cost of such arbitration, reasonable attorney's' fees and expenses of the prevailing party.
15.	In the event of undesirable behaviors, which include, but not limited to the following: signs of aggression and destructive behaviors, etc., Owner agrees that Kennel may "crate" the Pet. If this action does not solve the problem Kennel will notify Owner by telephone, text or e-mail and Owner agrees to promptly arrange to have the Pet removed from Kennel's premises. Prepaid boarding fees for unused days will be refunded to Owner. "Undesirable behaviors" shall be defined solely by Kennel.
14.	In the event of Pet's excessive barking, Owner authorizes Kennel to use anti-bark collar on Pet.
