President Josh Corbin called the meeting to order with quorum satisfied at 7:04 p.m.

Regular Business

Treasurer Sara Engelmohr read the minutes from the April 16, 2025, meeting. Debbie Clements motioned to accept the minutes as read; Randy Wilson seconded; minutes approved as presented.

New Business

Deb Greer advised that Sylvia Vigil (Code of the West Realty) stopped in at Water Department to inquire about placing a COTW business sign on the HOA lot at CR-510 & Navajo Road; also wanted permission to leave a small supply of "Spanish Peaks Region Recreation & Trail Guide" booklets at the Water Department for potential new property owners that might stop in. Deb agreed to the placement of the booklets and advised Sylvia that she would check with the HOA regarding a business sign. Those present discussed yard sign placement and consensus was to deny that request; however, further discussion suggested that maybe we could solicit local realtors and compile a list for placement inside the kiosk (perhaps with agreement for them to pay the equivalent of annual membership dues to the HOA for inclusion).

Deb Greer then also advised that the HOA book exchange was popular but, with new donations arriving for placement, she has begun a rotation donation with the Spanish Peaks Library.

Treasurer's Report - Sara Engelmohr

- 1) Plot plans will be prepared by a State Certified Surveyor (however, they accept hand drawn plans).
- 2) Previously, no shipping containers were allowed on property for storage; now they will be allowed as long as they have a pitched roof.
- 3) Mother-in-law quarters currently allowed in Filings 1 & 2, per our covenants; now, County has changed to second residence will be allowed on any property (must utilize same septic & water system).

Randy also advised that, for personal reasons, he needs to step away from chairing the ARC committee. He will be available to work with and advise whoever can pick up the position.
