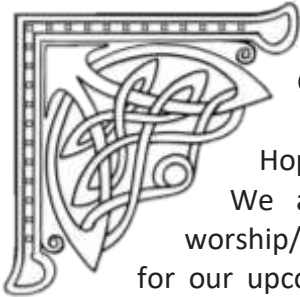

Opening Prayer

Review and Approval of January Minutes – January minutes were reviewed and unanimously approved. Adam moved, LouAnn seconded.

Review and Approval of January Financials – January financials were reviewed and unanimously approved. Cheryl moved, Jill seconded.

Memorial Fund Discussion – LouAnn gave a presentation on how memorial fund money has been spent over the year. Some of the items the memorial fund has spent money on include: new choir robes, new hymnals, helped pay for church siding, basement repairs, prayer garden benches, banners for altar committee and cemetery gates. All funds are spent on the church and /or property. Discussion was held on putting some of the funds into accounts which would yield better interest/earnings. This will be discussed at the next meeting.

Review church closing plan with new council members – The call tree was given to each council member.

Election of officers – Charmaine nominated Sue Miller for President. Sue accepted. Lucy nominated Jessica Staus for Vice President, Jessica accepted. Jessica nominated Charmaine Duehring for secretary. Charmaine accepted. Janene moved to accept all nominations, LouAnn seconded. The motion was approved. At this time Jill Paddock and Curt Hulterstrum left the meeting. Adam stayed.

Pastor Transition – Adam stated he has talked to the UCC Pulpit Supply to help find an interim (or bridge) pastor. He will help the new president with the transition. Adam then left the meeting.

Pastor's Report- A written report was presented and reviewed with Council. February 28 will be Pastor Glenn's farewell service.

Appoint Two Endowment Committee Members for a one year term – LouAnn Evert and Dan O'Keane have completed their 6th 1 year term.. Jill Paddock and John Duwell have accepted nominations to serve on the Endowment Committee for one year. Cheryl moved and Janene seconded and motion was unanimously approved.

Plans for Ash Wednesday, Easter and Lenten services – Ash Wednesday will be ZOOM only. Easter and Lenten services will be discussed with the interim/bridge pastor.

Next Council Meeting – Meeting will be in person on Monday, March 15, 2021 at 6 p.m.

Motion to adjourn was made by Charmaine, Janene seconded.
