## **What Does a Quarter-time Interim Pastor Do?**

I want to share with you what are my duties and responsibilities as your new Interim Pastor.

Basically an Interim Pastor helps the congregation get ready for the next pastor, who we call the "installed pastor" in the UCC.

I have fewer duties and responsibilities than did your previous pastor, the, inasmuch as she served you at full time, and I serve you at 1/4 time.

The responsibilities of a quarter-time Interim Pastor, as taken from the Interim manual, include:

1. Preparation and leadership of Sunday worship services, including scripture study, crafting of liturgy and bulletin, sermon preparation, guiding and sometimes finding lay liturgists, planning of music in coordination with the church musician(s), plus preaching, offering of prayers, etc.
2. Limited pastoral care, primarily Sunday conversations and weddings, funerals, and baptisms.
3. Home study and prayer to increase faith and to improve skills in leadership, teaching, and preaching.
4. Energizing and deepening the spiritual connections and faith understandings of members in all they do.

These are my basic responsibilities and duties, in case you were wondering.

Other responsibilities and tasks at church will be carried out by the Council members, other church leaders, and other laity. I am looking forward to serving you as your new 1/4 time Interim Pastor. -

## St. Paul's Women's Guild



September 19, 2021

1. The **meeting was called to order** at 10:30 a.m and Pastor Bev led a **prayer**.
2. Brett Miller gave an update on the **Search Committee's progress**. They have met 6 times and will have surveys ready for congregation in October. Committee is diverse representative of congregation and agree church should be a place where differences can be discussed in a safe atmosphere.
3. **August minutes** were read and approved.
4. **August financial reports** were discussed and approved. One third of Memorial funds will be moved to mutual fund this week . Giving is ahead of last year. New bench was purchased with memorial funds.
5. Pastor's report. Pastor Bev would like members to **wear name tags**. She would like to switch order of Joys and Concerns and Offering so persons could put a joy or concern on a paper and put in the offering plate to then be read to congregation.
6. The **membership list was finalized** and will be sent to Search Committee, Stewardship Committee, Financial Secretary, Bernice for records, and Donna for mailings and emailings. 115 adult members, 17 young adult members (confirmation-college), 14 children
7. The Guild will hold their **Cookie Walk on December 4**. The **Chili Luncheon will not be held** this year and an alternative fund raiser may be scheduled for spring 2022.
8. **Sunday School** meets every other week. Jodi will be asked to pick a **Christmas pageant date**, **Christmas Eve services** were discussed. 4:30 p.m. is scheduled but there may be an additional time needed to accommodate a larger than normal attendance.
9. Jack Duehring will be asked to **contact last year's snowplow company** to sign up for this year and get an estimate of the costs of plowing and salting this year.
10. The **Stewardship Committee** will be contacted by Charmaine to receive the updated membership list and to confirm dates for mailing letters and return of pledges by November 21. How the campaign is organized will be up to them. Pledge cards are being printed.
11. Liason reports: **Guild** – **New lights** for back hall will be purchased and installed so they light more quickly. **Choir** – will contact Pastor Bev about practice and singing **Building and Grounds** – Water test completed, new blind purchased and installed in conference room, windows painted next to front service doors. Step in conference room will be looked into.
12. The **next council meeting** will be Monday, October 18 at 6:00 p.m.
13. **Meeting adjourned** at 12:30.
