## **PASTOR'S MESSAGE**

Another month on the horizon. February. February is a short month, but it's full of meaning and opportunities to follow in Jesus' footsteps. Yes, it's still winter, but winter calls us to slow down. Not hibernate certainly, but a time to take care of ourselves.

February brings us Ash Wednesday (February 18) with the imposition of ashes marking the beginning of Lent. Lent, to me, is a time of personal reflection. A time to take stock of myself. And in addition, to set small, meaningful goals. As the days grow longer and the shadows lengthen, I remind myself to show greater gratitude and kindness not only here in church but outside of church.

The world outside our church doors has certainly turned cold and dark. Much of January's events weigh heavy on my heart and probably yours as well. What will February bring us? Lent calls us to slow down and turn our hearts to God in preparation for the joy of Easter.

February encourages us to reflect on our relationship with God, to practice kindness and generosity, to let go of distractions and habits that draw our attention away from what truly matters. Lent offers us a time to renew our hearts and minds. It is a sacred tradition, practiced for many Christian generations. You will not find it in your Bible, but its practices are rooted in Biblical themes...Jesus' 40 days fast in the wilderness - for example.

I have read that the word Lent comes from Old English and Germanic origins referring to springtime or lengthening of days. Apricity is another archaic word which in Latin means "the warmth of the sun in winter." Winter sunshine carries the coming of spring. As I write this on a cold and snowy January afternoon, that sounds so good to me.

As you journey through Lent, remember to be kind to yourself as well as honest. Stay safe. Stay healthy.
