## Castlereagh Estates Plats 1-4 Trustee Election

Due to special circumstances during the 2023 May meeting, Sheila Whittington was elected for a two year term as trustee/treasurer. Sheila has expressed interest in continuing as trustee/treasurer for the next 3 years. We are thankful for her service to our community.

Per 4.2 of the Castlereagh Estates Covenants & Restrictions, "at the annual meeting the lot owners present shall elect from the person or persons nominated by the lot owners present at the meeting a Trustee to serve for the next three years. A Trustee shall be elected by simple majority of votes casts, with each lot being entitled to one vote. In the event that no nominee receives a simple majority of the votes casts, a runoff will be held between the two nominees receiving the most votes at the meeting". Nominations will be taken from the floor.

#### Duties of the Treasurer:

- Prepare, mail and collect the annual assessment.
- Pay bills.
- Use accounting software to keep track of accounts, reconcile bank statements and create reports.
- Attend trustee meetings during the year and annual meeting in May.
