AGREEMENT FOR SERVICES

This AGREEMENT is entered into by and between Red Barn Holdings, LLC D/B/A Red Barn Inn (the "Red Barn Inn") and individual listed above ("Owner"):

Services, Fees & Payment Terms: Red Barn Inn will provide standard pet day care, boarding, grooming, training, exercise, and other services requested by Owner. Rates and fees are subject to change at any time, with proper notice, and owner agrees to pay for all services as services are rendered. A deposit may be required to hold your reservation for day care, boarding or other services as determined by the Red Barn Inn. Reservations cancelled less than 72 hours before the reservation date are subject to a loss of the deposit. A valid credit or debit card must be always kept on file. The Owner authorizes Red Barn Inn to charge the Owner's credit or debit card on file for any and all services, costs or fees associated with services rendered by Red Barn Inn.

Ownership: By enrolling the above named and described pet, I represent that I am the legal owner of the named pet and I assume all risks, dangers, liabilities, and responsibility for injuries to the named pet. Owner understands and agrees that Owner is solely responsible for any harm to Owner's pet while Owner's pet is attending day care, boarding, grooming or otherwise in the care of the staff at the Red Barn Inn.

Behavior Assessment: All pets must pass a general behavior assessment in order to attend day care, boarding, grooming or other services at Red Barn Inn. No pet will be admitted that shows any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's pet to Red Barn Inn, Owner is representing to Red Barn Inn that Owners' pet is in good health and has not harmed, shown aggression, or exhibited any threatening behavior towards any person or other pet. Any pet demonstrating aggression or other behavior deemed unacceptable by Red Barn Inn staff may be required to leave the facility.

Well Pet Requirements: Owner understands that Red Barn Inn has relied upon their representation that their pet is in good health at the time of check in for services at our facility. Any pre-existing health concerns or known allergies will be disclosed and discussed prior to check in. All pets under the care of Red Barn Inn must be spayed/neutered and current on all vaccinations listed below. All vaccines must be administered by a licensed veterinarian. The Owner must present current, written proof vaccinations for each pet prior to attending day care or boarding at all times. Although sick or unvaccinated pets are not permitted to attend Red Barn Inn, the Owner acknowledges that they are placing the pet into an area in which communicable diseases may pass between seemingly healthy pets. If following a provided service, the pet shows signs of illness, the Owner may not hold Red Barn Inn liable for any inadvertent exposure the pet may have contracted. Further, Owner understands and acknowledges that Red Barn Inn does not have a licensed veterinarian on site and may not be able to detect, diagnose or treat a medical condition in your pet.

All Pets are required to maintain the following current vaccinations:

Adult Dogs	Must be current on Rabies, Distemper/Parvo and Bordetella
Puppies	Must be 16 weeks or older & have received (2) Distemper/Parvo vaccines and (2) Bordetella vaccines
Cats	Must be current on Rabies, Distemper/FVRCP

Safety & Health: While all pets must pass the preliminary behavior assessment to be eligible for the services, some behaviors may be revealed only after a pet has attended day care or boarding for a number of days. If conduct deemed unacceptable or dangerous occurs and after our staff has taken measures to correct and re-teach the behaviors in question, Red Barn Inn reserves the right to immediately deny any pet eligibility at any time in the event that a pet shows the potential to cause severe injury or to be unwilling to adjust to the program. Pets must not have any conditions which can be aggravated by active play or have any contagious disease symptoms such as cough, cold, nasal discharge, etc. Although the Red Barn Inn environment is a safe and well supervised area, the Owner acknowledges that rough play can be an inherent part of pet behavior. Despite well trained staff and constant supervision, play may become too rough and an injury to pets may result. Should the pets require immediate treatment before the Owner can be contacted, the Owner authorizes Red Barn Inn to seek care for their pet from their primary veterinarian as deemed necessary. If the pet's primary veterinarian is unavailable, Owner authorizes Red Barn Inn and its staff to seek care from a local emergency veterinarian at the sole cost of the Owner. Following any injury, Red Barn Inn will attempt to contact the Owner as soon as possible, but regardless the Owner acknowledges and assumes all financial responsibility for treatment provided by signing this Agreement. Regarding behavior, if the Red Barn Inn determines that any pet shows excessive stress or aggressive behavior, the Owner gives permission for Red Barn Inn to separate the pet to an individual inside enclosure within our facility for the remainder of their visit without any offset or reduction in price. Red Barn Inn reserves the right to immediately deny any pet's eligibility at any time in the event that a pet causes severe injury or displays dangerous aggression.

Personal Items, Food, Medication & Supplies: Owner understands that Red Barn Inn is not responsible for loss, damage, or destruction of any personal items, food, medication, or other supplies left with your pet. Owner accepts responsibility to leave an adequate supply of food and medications for their pet during the entire duration of time under the care of Red Barn Inn. Should the food or medication supply need replacement, Owner authorizes Red Barn Inn to purchase replacement and Owner will reimburse Red Barn Inn for all costs plus a \$25.00 replacement fee per occurrence.

Photo Release: Owner understands that by allowing their pet to participate in services offered by Red Barn Inn, they hereby agree to allow Red Barn Inn and its staff, contractors or assigns to take photographs or use images of their pet in print or otherwise for publication, promotion, or social media.

Late Pick Up: Owner agrees that their pet is not picked up by closing time, Red Barn Inn is authorized to care of the pet for overnight boarding and will be financially responsible for applicable overnight boarding charge plus any charge for required food. A late pick up fee may also apply.

Abandonment: In the event that Owner abandons their pet during the term of this agreement without notification to Red Barn Inn, Red Barn Inn reserves the right to bill the credit card on file for all services rendered to date. If Red Barn Inn is unable to make contact with Owner, the pet will be transferred to the local animal shelter for further care and safekeeping. Red Barn Inn will make every attempt to transfer all contact information, belongings and information to the animal shelter upon transfer.

Acknowledgement of Risk & Limitation of Liability: Owner understands there are risks associated with group play in day care and boarding settings. These risks may include minor or major injury or common contagious canine illness that can be spread even with current vaccinations.

Owner also recognizes that there is an inherent risk of injury and/or illness in any environment associated with shared and unfamiliar spaces in a boarding environment. Owner acknowledges and agrees that Red Barn Inn, its staff, contractors, agents, or assigns are not to be held liable for any illness, injury, death and/or escape of Owner's pet provided that reasonable care and precautions are followed. Owner hereby releases Red Barn Inn, its staff, contractors, agents or assigns of any liability of any kind arising as a result of the Owner's pet attending Red Barn Inn. <u>Owner</u> understands and acknowledges that they are financially and legally responsible on behalf of their pet for any harm or damage, including to other pets, to the employees, contractors, agents or assigns of Red Barn Inn, equipment, facilities, or other property associated with such risks, including repairs, medical and veterinary costs. Owner shall indemnify Red Barn Inn against any loss, liability, damages, costs, or expenses (including attorneys' fees and costs) resulting from or arising out of Owner's performance or failure to perform its obligations under this Agreement.

Term of Agreement: This Agreement shall remain in full force and effect as between the parties until terminated otherwise cancelled or superseded by a writing signed by the parties.

Electronic Acknowledgement: This Agreement may be executed in multiple counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. This Agreement and any addendums or amendments hereto or thereto, to the extent signed and delivered by means of E-mail, a facsimile machine, or other means of electronic transmission, shall be treated in all manner and respects and for all purposes as an original signature, agreement or instrument and shall be considered to have the same binding legal effect as if it were the original signed version thereof delivered in person.

Entire Agreement: Owner understands and agrees that each of the foregoing provisions contained above shall be in force and effect and shall apply to each and every occasion on which Owner's pet is under the care of Red Barn Inn for daycare, boarding, grooming, or other services. The waiver by either party of a breach of any provision of this Agreement by the other party shall not operate or be construed as a waiver of any subsequent breach of the same or any other provision of this Agreement. If any provision of this Agreement is held inoperative, the remaining provisions shall remain in full force and effect. This Agreement shall be binding on and inure to the benefit of each of the parties hereto and their respective successors and assigns. This Agreement may not be assigned by Owner without the prior written consent of Red Barn Inn. This Agreement shall be governed by the laws of the State of Maine.

EXCEPT AS PROVIDED ABOVE, THE SERVICE IS PROVIDED "AS-IS", AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, RED BARN INN DISCLAIMS ALL OTHER REPRESENTATIONS AND WARRANTIES, EXPRESSED OR IMPLIED, REGARDING THIS SERVICE, INCLUDING ITS FITNESS FOR A PARTICULAR PURPOSE, ITS QUALITY, OR ITS MERCHANTABILITY.
