DOG BOARDING Hgreement

This contract (the "Agreement") is entered into between Finding Dori LLC (hereinafter referred to as the "Dog Boarding Company," "We," or "Our") and

(hereinafter referred to as the "Dog Owner," "You," or

"Your") by signing this agreement, you represent that you are the legal owner of the dog, and that your dog has current vaccinations as detailed below.

DOG BOARDING SERVICES

The Dog Boarding Company will provide a safe and sanitary environment for the dog(s) throughout the duration of the services. This includes ensuring that adequate shelter, sufficient food, and clean water are readily available to promote the dog(s)' well-being. The Dog Boarding Company acknowledges and agrees to adhere to the feeding schedule and dietary requirements specified by the Dog Owner. The dog(s)' medications will be administered according to the Dog Owner's explicit instructions.

DOG OWNER RESPONSIBILITIES

The Dog Owner should ensure that their dog(s) have the appropriate ID tags and collars for identification.

The Dog Owner should ensure the health of their dog(s) before check-in. The dog(s) should be free from contagious diseases for at least 7 days prior to their stay, and the dog(s)' vaccinations including but not limited to **distemper**, **adenovirus**, **parvovirus**, **parainfluenza**, **and leptospirosis** (often referred to as DAPP+L, Please note this vaccination is often a 3 year but the Lepto part of the vaccine must be updated yearly) **bordetella** (protects against kennel cough), rabies, and all other ailments as required by local statute.

In addition, flea/tick prevention & heartworm/dewormer prevention should be current. Please note, most preventions are required to be administered every 30 days. Please ask Dog Boarding Company directly if you have any questions on this. It is the Dog Owner's responsibility to ensure all dogs' vaccinations and preventions are up to date, if not, this contract acts as a wavier releasing the Dog Boarding Company from any liability of issues resulting in, omitted or expired vaccinations, out of date preventions, or false reporting. Proper documentation of current vaccinations or recent titer reports shall be provided or released to the Dog Boarding Company prior to drop off.

The Dog Owner will provide clear and detailed instructions for any required medications or special dietary needs, and any medications should be properly labeled. Any known dog behavioral issues or aggression triggers must be disclosed to the Dog Boarding Company. This information is essential for the safety of both the dog and boarding staff.

You understand that you are expected to provide your dog with sufficient food for the entire duration of his or her stay at the Dog Boarding Company.

If you do not provide sufficient food, the Dog Boarding Company may purchase and administer food of its choosing at fee of \$5 per meal.

DROP OFF & PICK UP

Drop off and pick up times are BY APPOINTMENT ONLY during the times of 7:45a-7:45p (if picking up after 5:30p for overnight boarding there will be an additional \$25 day board charge added). Drop offs/pick ups earlier than 7:45a will need to drop off/pick up the evening prior. Drop offs or pick ups later than 7:45p will need to drop off or pick up the following day. Dog Boarding Company often has other appointments (drop offs, pick ups, training, or other things scheduled) so please do NOT show up earlier than the scheduled time and please let Dog Boarding Company know if you will be late. Dog Boarding Company strategically schedules to avoid the chaos of multiple people and dogs showing up all at once. Dog Owner cooperation helps keep things running smoothly and safely for everyone.

(A quick text whenever Dog Owner is on their way for drop off or pick up is always appreciated so Dog Boarding Company can be ready for them/get them ready to go for you.)

HOLIDAY STAYS: If you are planning a stay over any holidays, please be aware NO drop offs, pick ups, or day boards are available on the holiday itself. Please plan for the day before or the day after. Thanks for understanding as we prioritize each dog's care along with family time during these busy times.

You understand that if you are late picking up your dog that you will be charged for any additional time that your dog remains at the Dog Boarding Company. If dog(s) are not picked up within 5 days of original pick up date and if the Dog Owner is no longer responding to communication attempts, dog(s) will be surrendered to local human society.

EMERGENCIES

In the event of a pet medical emergency, every reasonable effort will be made to contact the Dog Owner or emergency contact immediately. If this cannot be done in time, the Dog Boarding Company is authorized to seek the veterinary care necessary for the dog's health and safety.

The Dog Owner is responsible for all associated veterinary expenses. For any necessary non emergent medical care, if no response from Dog Owner within 24 hours, the Dog Boarding Company reserves the right to have dog(s) treated by a veterinarian at the Dog Owner's expense.

COST AND PAYMENT

The cost for overnight boarding is \$50/night with 20% off any additional dogs (please note this cost does not include any training services and would just be boarding only). Dog Boarding Company's nightly rate is all-inclusive, so there are no extra charges for medication administration, play time, or updates.

If you only need boarding during the day (plan to drop off (after 7:45a) and pick up same day (no later than 7:45p otherwise will need to do overnight board) then the **cost for day boarding** is \$30/day per dog (unless the day board is for a puppy under 5 months of age then it's \$38/day). *Please note if pick up/drop off times for day boarding are outside of normal hours (7:45a-7:45p) there will be an additional \$10 fee*

Other available services include a basic bath which is done at the end of the boarding stay for an additional cost. The basic bath cost for a dog who is under 40 pounds is \$30.00 and for a dog 40-89 pounds cost is \$40.00 and if your dog is 90 pounds and over the cost is \$55.00. (Please note: for any long haired dogs, including doodles, there is an additional \$10.00 fee on top of the cost of the bath since blow drying is required).

Bathing services are only available with overnight boarding. Also, because our holiday bookings are extra full, baths are NOT available over holiday stays, thanks for understanding as we prioritize each dog's care along with family time during these busy times.

You agree to pay us for the Services we provide to your Pet during each visit at the rates set forth at the start of such visit (collectively the "Charges"). Prices are subject to change without notice. Charges begin on the day you leave your Pet. If you do not pay your bill in full at check-out, you understand you will remain liable for all Charges incurred during your Pet's stay, and Dog Boarding Company the right to collect any unpaid balance.

Gratuities: We strive to provide the highest standard of care for your pets, and while tips are never expected, they are always appreciated as a way to recognize the extra time, care, attention and effort that goes into ensuring your pet's comfort and well-being during their stay with us. For clients who prefer non-monetary appreciation, leaving a positive review on Facebook or Google or sending referrals our way, which also supports our small business, is also greatly appreciated.

Payment is due in full at pick up. Venmo, Paypal, and cash are accepted.

UPDATES

While Dog Boarding Company does their best to provide photo updates during your dog's stay, they care for multiple dogs at a time and are unable to provide daily updates. Thank you for understanding as Dog Boarding Company prioritizes hands-on care and safety throughout each day. In general, Dog Owner can expect:

- 1 update for 1-3 day stays
- 2 updates for 4-6 day stays
- Additional updates may be provided for extended stays (over 7 days)

Updates are typically sent in the evenings after 7 PM.

You give the Dog Boarding Company permission to take photos and/or videos of your dog for use in advertising and promotional materials, and any photos so taken become the property of the Dog Boarding Company.

CANCELLATION AND TERMINATION

The Dog Boarding Company reserves the right to cancel or terminate services at any time due to reasons that may include but are not limited to aggressive dog behavior or false information provided. Should the Dog Boarding Company cancel the Services, the Dog Owner will be notified promptly. In case of termination, the Dog Owner may not be entitled to a refund of any balance due.

ASSUMPTION OF RISK

You hereby give the Dog Boarding Company permission to care for your dog(s). The Dog Boarding Company will use leashes, collars, and other appropriate means of maintaining safe and orderly control of all dogs. You understand and acknowledge that your dog may be kept in the company of other dogs during its stay at the Dog Boarding Company. You understand the Dog Boarding Company is not responsible or liable for any of the following: injuries to your dog(s) caused by other dogs (including incidents of biting or scratching); diseases or ailments; infections and viruses; loss by natural causes; natural disasters; fire; theft; running away; injury to a person, animals or property; or self inflicted injuries caused from ingesting foreign objects, chewing, biting, scratching during the term of the boarding.

RELEASE OF LIABILITY AND INDEMNIFICATION

You hereby release the Dog Boarding Company from all actions, suits, or claims for injury, loss, or damage regardless of the cause. You release the owner of the property, which the Dog Boarding Company occupies, from all actions, suits, claims for injury, loss, or damage regardless of the cause.

You understand and acknowledge that dogs can be unpredictable and may cause harm to themselves, other dogs, persons, or property. You agree to indemnify and hold harmless the Dog Boarding Company for any and all losses, liabilities, demands, expenses, claims and suits. The parties expressly agree that this release of liability and indemnification shall be given full force and effect in accordance with each and all of its terms and provisions. You understand this Agreement is a contract between the you and the Dog Boarding Company, and that you sign it freely, openly, and without reservation.

ENTIRE AGREEMENT

This contract constitutes the entire agreement between the Dog Owner and the Dog Boarding Company regarding the services and supersedes all prior discussions, understandings, representations, and agreements, both written and verbal.

FORCE MAJEURE

Neither party shall be held accountable for unforeseeable circumstances or events beyond their control, including acts of nature, government actions, war, epidemics, or other events hindering the contract's performance. The affected party must promptly notify the other party and make reasonable efforts to mitigate the event's effects.

SEVERABILITY

If any provision of this Agreement is found to be invalid, illegal, or unenforceable under applicable law, the invalidity, illegality, or unenforceability of such provision shall not affect the validity or enforceability of the remaining provisions of this Agreement.

No modification, amendment, or alteration of this Agreement shall be binding unless it is made in writing and duly executed by both parties. By signing below, both parties acknowledge and agree to the terms and conditions stated in this Agreement.
