Nolensville Historical Society Chili Cook-Off Rules and Regulations

Sign Up. One member of each Team shall be designated Team Captain. A cook-off entry form and a Liability Waiver signed by the Team Captain, as well as the \$25 entry fee must be submitted to reserve a table. Payment of the entry fee may be made online or in person. Because contestant space is limited, on-site registration will not be permitted unless specifically approved by the Event Coordinators. In addition, a Liability Waiver must be signed and submitted for each team member to participate in the event. Liability Waivers for team members may be submitted in advance or upon check in on the day of the event.

Check In, Set Up & Tear Down:

1. Check In will be from 1:00-2:00 PM. Contestants/Teams will be assigned a table and a table number upon check in. Contestants are asked to arrive in time to complete check in before 2:00 PM. Contestants/Teams may begin setting up their table once check in is complete. The Team with the best table display will receive a prize.
2. Teams are expected to decorate their table and are responsible for providing their own decorations, including a sign displaying the Team name, the chili recipe name, and the spiciness level:
 - a. 5 stars = HOT
 - b. 4 stars = Medium to Hot
 - c. 3 stars = Medium
 - d. 2 stars = Medium to Mild
 - e. 1 star = Mild
3. Set Up must be completed by 2:45 PM.
4. The Judging Panel will begin judging at 3:00 PM.
5. The People's Choice voting will begin at 3:00 PM. All People's Choice votes must be submitted by 4:00 PM.
6. Public dining will be from 4:00-7:00 PM.
7. Tear Down will be from 7:00-8:00 PM.
8. Contestants/Teams are responsible for tear-down and clean-up of their table and the surrounding area. Teams that run out of chili before the event ends are asked to put the "SOLD OUT" sign provided by the Event Coordinators upon check-in on their table. Teams are asked not to break down their table until the end of the event at 7:00 PM. Contestants/Teams **MUST** be present to receive any prize.

Chili Cooking Rules:

1. Contestants/Teams are expected to bring their own crockpots. Teams may have a maximum of two (2) crockpots,
2. Contestants/Teams are expected to provide two (2) or more gallons of chili.
3. Contestants/Teams are expected to bring their own serving utensils, a garbage bag or receptacle, and food service gloves.
4. Chili must be fully prepared off site, in advance of the event, and brought on site by 2:45 PM on the day of the event.
5. Event Coordinators will provide sample/tasting cups for People's Choice voting. Event Coordinators will provide bowls, napkins, and chili toppings/"fixins" for on-site dining. Take home portions will also be available for purchase separately.
6. For safety and sanitary reasons, at no time should chili be left unattended. Event Coordinators reserve the right to disqualify any contestant for food or equipment safety reasons if necessary. **For safety reasons, bowls and cups may not be refilled**
7. Open flames of any type are expressly prohibited.

Peoples' Choice Award: There will be a People's Choice Award for the best chili. Tickets for voting and sample/tasting cups will be provided to the public upon purchase of a voting package. Each team will have a ballot box on their table for People's Choice voting submissions. People's Choice voting ends at 4:00 PM, at which time the Event Coordinators will tally the votes for each Team. The People's Choice winner will be the team with the most tickets/votes. Winners will be announced and posted on the Winners' Board once the vote tallying process is complete.

Judging:

1. Contestants will submit eight (8) ounces of chili for the Judging Panel in the numbered cups provided by the Event Coordinators upon check in.
2. Criteria for judging is as follows:
 - a. LOOK - the appearance of the chili
 - b. TASTE - the most important factor, how well the flavors blend together
 - c. CONSISTENCY - the ratio between sauce, and other ingredients
 - d. AROMA - the smell of the chili
3. There will be a first (1st), second (2nd) and third (3rd) place prize awarded to the winners selected by the Judging Panel. Winners will be announced and posted on the Winners' Board once the judges' votes have been counted. The decision made by the Judging Panel is final.
4. Awards include 1st, 2nd & 3rd Place awarded by the Judging Panel, a Mayor's Choice Award, and a People's Choice Award..
