The Board went into executive session until 7:25 pm

Director's, Secretary's, Treasurer's Reports for December:

Tim S. stated we would have the three reports presented and discussed at the February meeting.

Motion was made to table all reports for January to the February meeting:

Snow Plow Day is scheduled! Flyers have been sent to Elbridge and to the school district. Plans are in the works to contact the Village Police for an event in the Spring and possibly the Fire Dept in June. Steve and Tim discussed the liability issues we need to finalize prior to the event. Steve stated he would keep in touch with Vern Richardson at the Town.

The Library turns 101 this year and we need to celebrate!!

Jessica DeCapio, staff member, is looking to start a Seed Bank in the library. Tim stated he didn't know what that was. Stew stated it can be a very complicated process. Mindy asked what type of seeds would be involved.

Linda B. (with armored guards) went to the bank to not only deposit the \$500 check from the Friends, but also the checks from our state construction grant and monies collected by the school district for the year!

Next month, Linda will have the Christmas Raffle names and figures.
