...with Revenue of \$3,001,000 or more
(Averages \$105.00 per hour for 30 to 75 hours)

2 to 3 Agencies Applying for One Grant Collectively

(Averages \$175.00 per hour for 35 to 80 hours)

4 to 6 Agencies Applying for One Grant Collectively

(Averages \$200.00 per hour for 60 to 80 Hours)
