**IF VENTURE IS FOR GOLF LESSONS:** If approved, the Outside Agency will be granted use of a designated 1/2 of the driving range, 1/2 of the chipping green and 1/2 of the putting green. Use of 1/2 of these facilities will allow the HPRAI membership or greens fee paying patrons continued use of these areas. These areas will be roped off, so the participants of the commercial venture and members and patrons will have a boundary of the designated property.

Any Outside Agency approved to provide golf lessons shall pay a minimum of \$25 per day or eight percent (8%) of gross receipts, whichever is greater, to HPRAI, plus 1/2 the cost of range balls used by participants of the commercial venture during the golf lessons.

If non-member participants of the commercial venture want to use the actual golf course beyond the designated areas, they must pay to HPRAI the designated weekday or weekend greens fees. If participants want to use the driving range after their lessons are completed, they must pay full price for range balls, unless the participant is a member with a range ball pass.

I have read, understand and agree to abide by all rules and policies for use of HPRAI facilities for a commercial venture. I acknowledge that HPRAI is not liable for acts and omissions that may cause personal injuries to any person or damage to any personal property arising from any act or omission by the Outside Agency. I further agree to indemnify and hold the HPRAI, its agents and employees harmless from damage, claims, actions, liability and expenses from or in connection with the Commercial Venture requested.
