

# Non-Disclosure Agreement (NDA)



This **Non-Disclosure Agreement** (the "Agreement") is entered into as of the date signed below, by and between **Kisuucon** (the "Disclosing Party") and the individual cast member or participant (the "Receiving Party") who is participating in the production of the **Anime Soirée Stage Show**.

## 1. Definition of Confidential Information

For the purposes of this Agreement, "Confidential Information" refers to any data, information, or material related to **Kisuucon**, **Anime Soirée**, or its associated operations, including but not limited to:

- Scripts, storylines, characters, and plot details of the **Anime Soirée** stage show.
- Plans, schedules, budgets, and any internal documents related to the production of **Anime Soirée**.
- Technical specifications, room layouts, and performance setups.
- Cast and crew lists, attendee lists, and any personal information regarding the cast, crew, or attendees of **Kisuucon**.
- Marketing strategies, promotional material, and any pre-released media, including photos and videos.
- Any unreleased content, including videos, music, or special effects used during the production.
- Information regarding guests, special performances, or surprise appearances at **Kisuucon**.

## 2. Obligations of the Receiving Party

The Receiving Party agrees:

- To keep all Confidential Information strictly confidential.
- To not disclose any Confidential Information to any third party without prior written consent from **Kisuucon**.
- To not use the Confidential Information for any purpose other than their involvement in the **Anime Soirée** stage show and **Kisuucon**.
- To take reasonable precautions to protect the confidentiality of the Confidential Information.

## 3. Exceptions to Confidentiality

The obligations under this Agreement do not apply to information that:

- Is or becomes publicly available without breach of this Agreement.
- Is received from a third party lawfully entitled to disclose such information without any obligation of confidentiality.

- Is independently developed by the Receiving Party without use of or reference to the Confidential Information.
- Is required to be disclosed by law or regulation, provided that the Receiving Party gives prompt written notice to **Kisuucon** to allow for an opportunity to contest or limit such disclosure.

## 4. Ownership

All Confidential Information shall remain the property of **Kisuucon**. No license or right under any trademark, copyright, or other intellectual property right is granted or implied by this Agreement.

## 5. Term

This Agreement shall be effective from the date of signature and remain in effect during and after the **Anime Soirée** stage show and **Kisuucon**. The obligations regarding confidentiality shall survive indefinitely.

## 6. Remedies

In the event of a breach or threatened breach of this Agreement, **Kisuucon** shall be entitled to seek injunctive relief, as well as any other rights or remedies available at law or in equity, including damages.

## 7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the state of **Oregon** without regard to its conflicts of law principles.

## 8. Miscellaneous

- **No Waiver:** Any failure to enforce any provision of this Agreement shall not constitute a waiver of any rights.
- **Amendments:** This Agreement may not be modified except in writing, signed by both parties.
- **Entire Agreement:** This Agreement constitutes the entire agreement between the parties concerning the subject matter hereof, and supersedes all prior agreements.
