## **Exhibition Room Breakdown:**

Sunday: 6:00 PM – 12:00 AM

For those arriving on Thursday between 1:00 PM and 12:00 AM, the Exhibitor check-in table near the back of the hall, by the loading dock, will be available. Late check-ins after 1:00 PM on Friday should be done at the volunteer registration table at the front of the convention center.

Assignments will be confirmed before the event, and badges must be collected at the show, not mailed beforehand.

Space assignments will be managed by the organizers, accommodating special requests where possible. More information on electricity will be provided closer to the show.

**Standard Corner Booths: \$475**

Standard Inline Booths: \$425

Standard booths are 8×8 with Pipe and Drape, 2 chairs, and 2 Badge, designed for vendors of original and branded products related to Kisucon's culture.

**Artist Alley/Craftsperson Tables: \$215**

Artist spaces are approximately 6 feet wide by 3 feet deep and come with (1) six-foot long table, 2 chairs, and 2 Badges. These spaces are reserved for aspiring artists and writers selling/promoting their own personal work.
