Third, military assets will be divided base by base with one side choosing one and then the other choosing one with a coin toss to decide who chooses first. Upon completion of that exercise, it will be the owning nation's responsibility to maintain and populate the base. The location of said base

will be sovereign territory of that nation, regardless of which nation it may be a physical part of. The service academies cost will be split 50/50 with each nation allotted those slots to ensure good relations among the nations.

Fourth, there shall be no tariffs between the nations.

Fifth, the FSA will take the judges on the Supreme Court-appointed by Republican presidents, and the LSA shall take those appointed by Democratic presidents as the foundation of their new courts.

Sixth, each nation will have the exclusive right to set its own immigration policies and can deny—for any reason—citizenship or legal alien status as they see fit. If a resident of the LSA bore a child in the FSA or an FSA resident bore a child in an LSA state, the parents shall have the exclusive right to choose what nation that child shall be a resident of. No person that is in either nation illegally and bears a child shall have the right to claim that child as a citizen of that

nation. However, should the LSA or FSA decide to wave that restriction through constitutional amendment, that is fully within their right as a sovereign nation, but it does not apply to the other nation.

"May you, your husband and your kids burn in hell," said one email. The other told her she should tell Brett Kavanaugh to "put a bullet in his ... skull,". Those statements, cleaned up just a little, could have been written by or were stated by every senator, save maybe one from the LSA. I for one will not stand by while your representatives treat my fellow American in this manner. look at the inner-city conditions, the people they say they “care” about most, to realize they need to file for divorce as well.



we have 7000 pages of laws is because man cannot follow ten written in stone.”


