Business Plan

Mission

Our mission is to give formerly incarcerated men a real shot at rebuilding their lives—starting with safe, faith-based housing, hands-on job training, and practical life skills. Our goal is to help them reenter society with dignity, hope, and restore their sense of purpose—breaking the cycle of recidivism not just in Texas, but wherever this kind of second chance is needed.

The Need: Recidivism and Barriers to Reentry

- The U.S. has one of the highest incarceration rates globally, with over 600,000 individuals released from prisons annually. Nationally, 68% of released prisoners are rearrested within three years.[5]
- Texas' three-year recidivism rate is 20.3%, but state jail felonies can reach up to 63%.[3][5]
- The economic cost of incarceration is staggering. The average cost to incarcerate a person in the U.S. is \$31,286 per year.[1]
- Employment is a critical barrier—60% of formerly incarcerated individuals remain unemployed one year after release.[4] Legal restrictions bar many ex-offenders from jobs in education, healthcare, and licensed trades, leaving mostly low-wage, entry-level positions.[1]
- Education is a major factor: Nearly 80% of incarcerated individuals lack a high school diploma, and only 33% use prison-acquired skills in their first job post-release.[1]
- Correctional education – ex-offenders who participate in educational or vocational programs reduces the odds of re-incarceration by 43%.[2]

The Solution: Our Program

To provide funds to these men and the means to be successful. Whether it is initial funds for just the basics (food, clothing, housing etc.) when they first come home from prison and re-enter society. Or funding their vocational/education needs to get better jobs. Or have the funds to buy more homes for these individuals, build a school, purchase apartments/hotel/motels and turn them into homes for these men.

Transitional Housing

- Safe, structured, and affordable housing for up to six men per home.
- Family-style environment fostering accountability and brotherhood.

- Six-month minimum stay, house rules, and a three-strike behavioral policy.

Vocational Training

- Training in HVAC, electrical, plumbing, construction, automotive repair, welding, property preservation, etc..
- Plans for internal vocational enterprises such as trucking and property preservation services.

Job Placement Support

- Resume building, interview coaching, and direct job placement assistance.
- Transportation support for job interviews and work sites.

Life Skills Education

- Daily workshops covering financial literacy, credit repair, tax filing, conflict resolution, and personal growth.

Spiritual Development

- Christian-based peer support, Bible study, and mentorship.

Target Market

- Primary: Justice-involved men recently released from incarceration in Texas who are committed to turning their lives around through faith, personal growth, and structured support.
- Secondary: Community partners, businesses, churches, and donors passionate about second chances.

Vision

To create a network of transitional homes across Texas that prepare and launch formerly incarcerated men into stable, purpose-filled lives—anchored in faith, family, and community transformation. Most importantly, to be able to purchase apartment complexes and houses for men who have succeeded and want to live on their own.

Impact Goals

- Reduce recidivism among ARK House participants to below 10% within three years of completion.
- Achieve 100% employment among participants within 30 days of entry.

- Expand to serve 100+ men annually by year five through housing expansion and vocational programs.

Operations Plan

- Facilities - Start with one fully furnished 3-bedroom, 2-bath home in Houston, housing 6 men, with expansion to additional homes as funding allows.
- Staffing - One full-time house director at launch managing daily operations.
- Daily Activities - Structured activities including spiritual support, job training, chores, and life skills classes.

Financial Plan

- Startup Investment: \$14,000 for repairs, furnishing, and initial licensing/permits.
- Year 1 Budget: \$150-\$200k for home acquisition, operations, and truck purchase.
- Years 2-3: \$300-\$500k for vocational school, staffing, and multi-home expansion.
- Ongoing support for new housing, staff, and program enhancements.

Revenue Streams

- Modest program fees from residents (averaging \$600/month).
- Income generated through vocational enterprises, such as hauling, delivery services, minor home renovations, and property preservation work.
- Contributions from individual donors, grants, and corporate sponsorships.

SWOT Analysis

Strengths

- Faith-based, holistic model
- Structured housing with accountability
- Clear mission, scalable model

Weaknesses

- Limited initial funding
- Small launch team
- Need for more staff/facilities

Opportunities

- Expansion to other cities
- Job creation via business ventures
- Partnerships with local trades

Threats

- Community stigma toward ex-offenders
- Safety concerns from local residents
- Competitive nonprofit funding

Community Engagement

- Addressing Concerns - Host community forums to discuss safety protocols and accountability.
- Partnerships - Collaborate with faith groups, employers, reentry agencies, and local government.
- Communication - Regular reports on outcomes, resident progress, and community benefits.

Why This Works

- Vocational education and structured reentry programs reduce recidivism by 43%.^[2]
- Successful reentry lowers public spending and boosts local economies.
- Stable housing and employment are the two most critical factors for reducing reoffending.^{[1][4]}

Key Statistics at a Glance

- U.S. 3-year recidivism rate: 68%
- Texas 3-year recidivism rate: 20.3% (up to 63% for state jail felonies)
- 60% of formerly incarcerated people are unemployed one year post-release
- Correctional education reduces recidivism by 43%
