Heart of Texas Akita Club (HOT)

Code of Ethics

As a HOT member, I will strive to promote the highest values among Akita owners and breeders and ensure the continuous improvement of Akitas within the framework of approved breed standards. I agree to uphold this Code of Ethics and do what is possible to protect and preserve the purity, health, welfare and well being of Akitas.

I will:

- 1) Observe the highest standards of sportsmanship and good will at shows, obedience trials, and at any other event involving Akitas.
- 2) Attempt to help and befriend novice exhibitors and owners and assist all newcomers to the breed so they may be guided in the ways that can best preserve and continuously improve the Akita.
- 3) Encourage all Akita owners to socialize their dogs with other people and pets.
- 4) Encourage all Akita owners to participate in basic obedience training for their Akitas.
- 5) Keep accurate registration, health and breeding records on all my dogs and provide this information whenever one is sold or placed in a new home.
- 6) Refuse to deal with dog wholesalers or to sell puppies to pet shops. Include in all stud contracts an agreement to be signed by the owner of the bitch that no puppies resulting from the mating be wholesaled, sold, or given to pet shops or wholesale dog breeders or dealers.
- 7) Refuse to wholesale, buy or sell any registered breed of dog, singly or in litter lots, realizing that we as dog fanciers are responsible for not only our own breed but for others as well.
- 8) Shall not give Akitas as prizes, offered in raffles or sold at auctions, nor shall Akitas be exploited in any detrimental manner.
- 9) Recognize that Breeders have a lifetime responsibility for puppies produced by their brood bitch.
- 10) Encourage owners to permanently identify all dogs and register them with an organization that will help return the lost dog. (Such as the AKC Companion Animal Program)
- 11) Contain my dogs within safe areas when not able to personally supervise their safety.
- 12) Keep my Akita dog healthy by:
 - a) Regular vet examinations and keeping up-to-date with shots and on heartworm prevention.
 - b) Providing proper housing, care, food, grooming, exercise and safety.
- 13) Attempt to help Akitas found in a rescue type situation by assisting the owners when possible or reporting it to the proper authorities if required.
- 14) Include consideration of my Akitas dogs in any wills drawn up. I will notify and discuss these plans with other individuals asked to take possession of my dogs beforehand. I will ensure that health, registration, breeding and identification records for all dogs will be readily available.

15) Before planning to breed my Akita, I will:

- a) Keep well informed in the field of genetics and work to eliminate hereditary defects from the breed.
- b) Participate in recommended health examinations per the national breed club Akita Club of America
- c) Follow the breeding guidelines and Code of Ethics for breeding established by the national breed club Akita Club of America.
- d) Breed only mature, healthy, and registered Akita dogs and bitches that have passed all their required health exams and are of stable temperament.
- e) Carefully analyze the conformation and pedigrees of prospective sires and dams with an eye to improving the sire and dam and will refuse any breeding that will not be in the best interest of the breed. If stud service is denied, fully explain the reasons to the owner of the bitch.
- f) Sell all puppies and adult dogs (if their breeder) with a written health guarantee.
- g) Companion or pet dogs should be sold with a spay/neuter contract requiring altering by the age of six (6) months if they are not altered before being sold.
- h) Not release puppies under the age of eight (8) weeks to new homes and fully explain Akita ownership to all buyers
- i) Be available to all buyers at any time for help during the life of their Akita.
