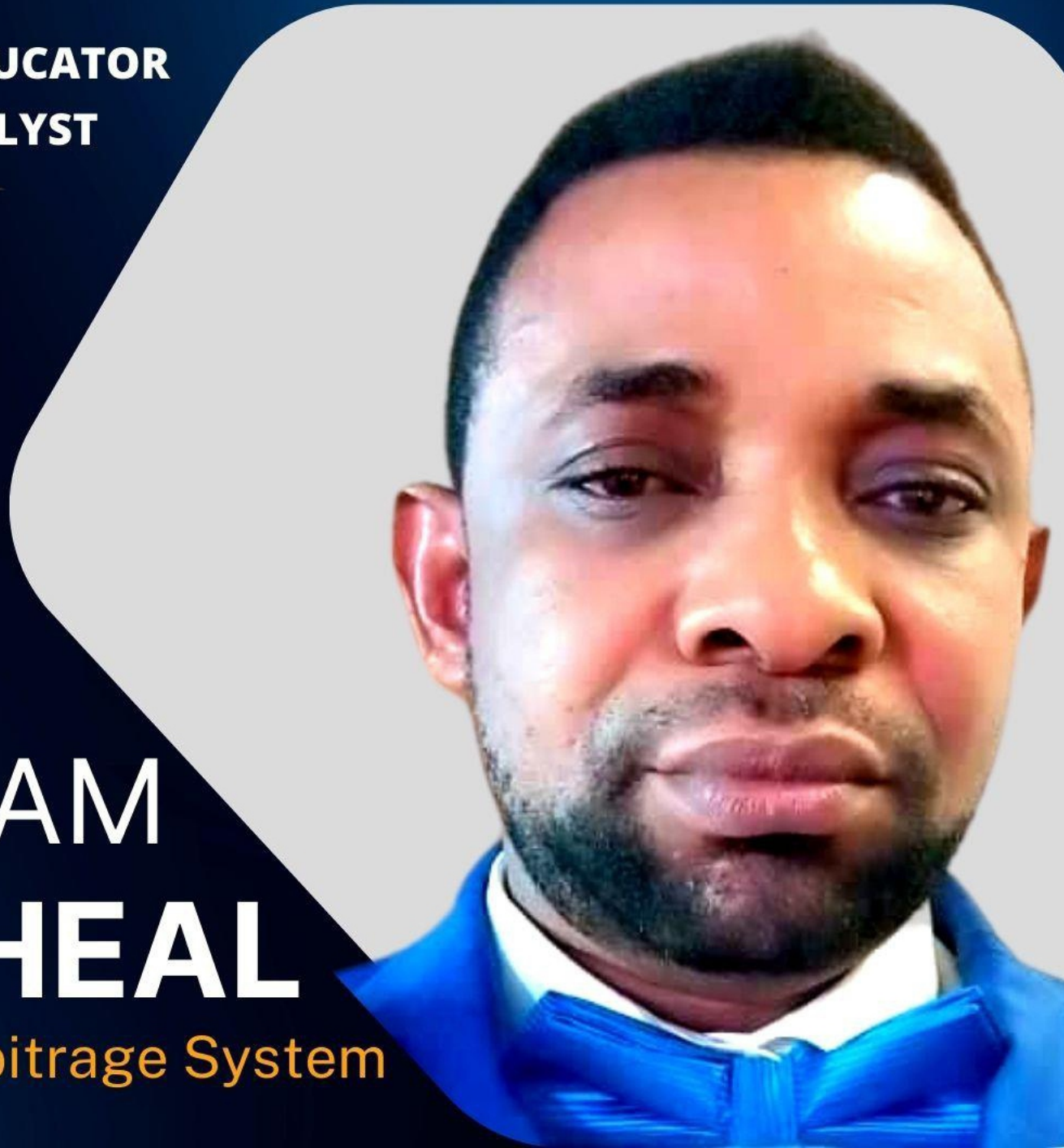

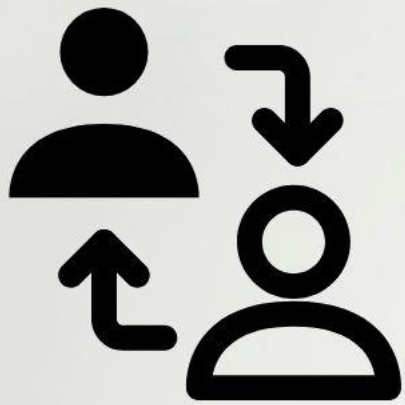

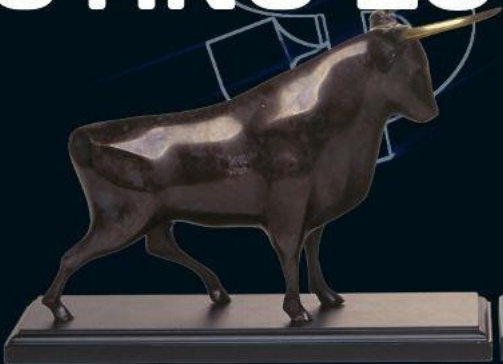

HIGH-FREQUENCY TRADING, ALSO KNOWN AS HFT, IS A METHOD OF TRADING THAT USES POWERFUL COMPUTER PROGRAMS TO TRANSACT A LARGE NUMBER OF ORDERS IN FRACTIONS OF A SECOND

WHAT IS ALGO?

ALGORITHMIC TRADING (ALSO CALLED AUTOMATED TRADING, BLACK-BOX TRADING, OR ALGO-TRADING) USES A COMPUTER PROGRAM THAT FOLLOWS A DEFINED SET OF INSTRUCTIONS (AN ALGORITHM) TO PLACE A TRADE. THE TRADE, IN THEORY, CAN GENERATE PROFITS AT A SPEED AND FREQUENCY THAT IS IMPOSSIBLE FOR A HUMAN TRADER.

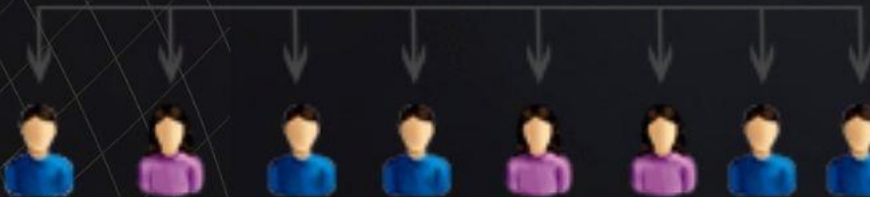

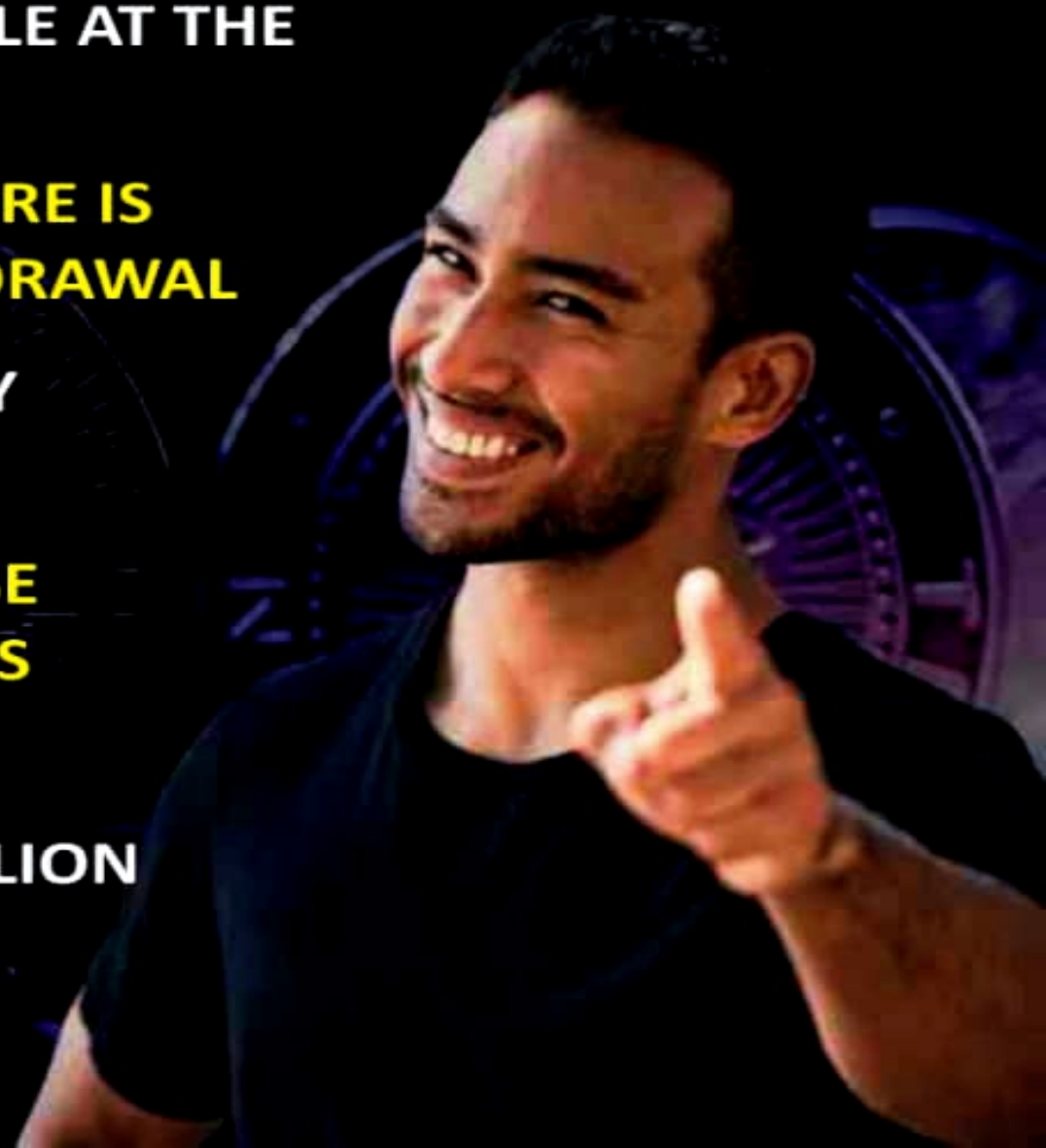

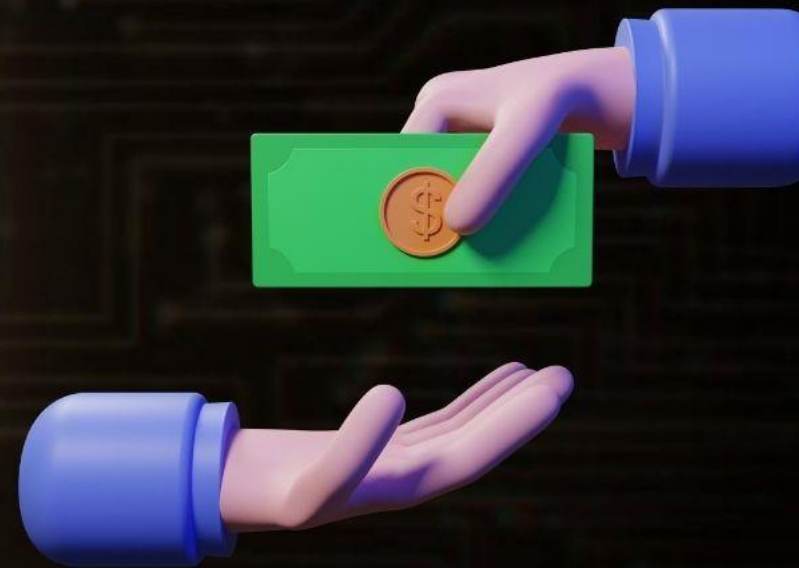
