# HUNTING CONTRACT

1. This agreement entered between Cedar Ridge Outfitters LLC – (hereinafter referred to Outfitter) and the endorsed sportsman sets out all aspects of the complete agreement between the parties, and reflects the final agreement concerning the services to be performed and goods provided by Cedar Ridge Outfitters LLC as well as respective rights and duties of the parties. There are no implied terms to this agreement other than those expressly set forth herein. You are purchasing a “fair chase” hunt in Wyoming. As such, this contract or any articles herein do not guarantee or promise the below undersigned a kill or a shooting opportunity. Certain licenses for which you may be applying are subject to a successful draw.
2. Hunting Area: Areas may include multiple units as set by Wyoming Game and Fish and can include private, BLM or State Lands.
3. **OUTFITTER SHALL FURNISH:**
  - Sleeping, dining and toilet facilities.
  - Dining will consist of at least two “sit down” meals per day, plus a field type luncheon meal/snack.
  - Game handling from the field to the cabin and/or transportation to processing plant within a reasonable time period based on weather and plant operating hours.
  - Transportation to and from Casper, WY airport if you are arriving via air.
4. **SPORTSMAN SHALL FURNISH:**
  - Sleeping Bag, towel, toiletries, personal hunting gear and other items of personal comfort.
  - Special dietary need items. Although we will make reasonable efforts to accommodate any dietary needs, we are made aware of, please bring any specific items you may need.
  - Helmet and any other safety equipment if you desire to wear while in UTV or in the field.
  - Weapons and ammunition, which are legal for the taking of game in Wyoming. If you wish to have your rifle in a scabbard while riding in UTV or pick-up, please bring one. We do have extras but often find they do not fit many of the custom scopes and rifles.
5. **SPORTSMAN’S DUTIES. ALL HUNTERS SHALL AT ALL TIMES:**
  - Conduct themselves in a polite manner.
  - Practice firearm safety.
  - No consumption of alcohol during hunting hours, or possession of non-prescription or illegal drugs according to Wyoming statutes.
  - Observe all hunting and cabin rules as presented by Outfitter either in writing or verbally.
  - Strictly adhere to all Wyoming Game and Fish Department regulations and Ranch rules pertaining to hunting and hunting safety.
  - As required clients shall sign a liability waiver and acknowledgment of the wounding policy. (Included at end of agreement)
6. **THE UNDERSIGNED SPORTSMAN UNDERSTANDS AND AGREES THAT:**
  - Hunting activity involves certain inherent risks of loss or injury or illness that each hunter assumes that risk of loss and injury and illness and furthermore agrees to indemnify and hold harmless Cedar Ridge Outfitters, its employees, agents, contracted personnel and Cedar Ridge Outfitters’ Private or Corporate Property Lessors from any and all liability, costs, claims and demands whatsoever, including costs of any legal action, including reasonable attorney’s fees.

- Hereby give permission for Cedar Ridge Outfitters to use picture and name for future promotional and marketing purposes (e.g., website, brochures, hunt albums, etc.)
7. FINAL PAYMENT MUST BE MADE IN THE FORM OF CASH, CASHIERS CHECK, MONEY ORDER AND/OR MAJOR CREDIT CARD UPON ARRIVAL. Personal checks will not be accepted as final payment.
- Deposits represent reservation of space that is then unavailable to other hunters and are not refundable except as provided in refund policy (Attached).
  - There shall be no refund or prorating due to inclement weather nor if for any other reason beyond the control of Cedar Ridge Outfitters, the hunter shall be asked to leave the lodge prior to the expiration of his hunt.
  - If a sportsman is unwilling to abide by all of the terms of this agreement and rules of the cabin, then, at the sole discretion of Cedar Ridge Outfitters the hunter shall be asked to leave the lodge and the hunt canceled with no refund.
  - **ALL PRICES IN U.S. DOLLARS, ADD 3% for all credit card transactions. Credit card fees are not refundable.**
  - **THE COST OF YOUR HUNT INCLUDES:** All meals and lodging while you are in the lodge, UTV and/or pick-ups when used, transportation to meat processor and/or taxidermist located in Casper, WY. Transportation to and from airport in Casper, WY.
  - **THE COST OF YOUR HUNT EXCLUDES:** Fees for hunting licenses and tags, gratuities to guides, meat processing, taxidermy, shipping of meat and trophies, alcoholic beverages, extra trips to town for your personal needs. Any travel, accommodation and meals prior to Day 1 of hunt and after departure from lodge.
  - Cedar Ridge Outfitters relies that you are an outdoors person and have sufficient hunting skills and abilities for the type of hunt booked, along with intimate knowledge of the operation of your weapon and that you are in good physical shape. All physical limitations or health problems must be made known to Cedar Ridge Outfitters in writing as well as verbally to your guide. You must also assume all responsibility for such conditions and hold Cedar Ridge Outfitters harmless thereto as described above and in the WAIVER LIABILITY (Attached).
  - Hunting procedures and activities by Cedar Ridge Outfitters depend on weather, game conditions, skill and physical conditions of the hunters. Cedar Ridge Outfitters may in its sole discretion, makes changes to best increase your opportunity to make your hunt successful.
8. Each undersigned acknowledges that he has read all the information material sent by Cedar Ridge Outfitters or read on the web site, including the brochure and date/price sheet pertaining to specific hunting dates, outfitter fees, license fees, accommodations, services provided, location and terrain description of hunting areas, weather considerations, game conditions, and hunting methods. Where differences exist, this written contract controls. This agreement shall be binding upon the parties hereto, their heirs, representatives or agents and shall not be assigned without the specific written approval of all parties.
9. Any lawsuit, judicial proceeding, or any other action concerning this contract or provisions hereof shall be instituted only in the State of Wyoming, Natrona County.
10. **CONFIDENTIALITY:** We at Cedar Ridge Outfitters want you to be able to share your adventure, success and experience with others. However, please refrain from posting any proprietary information about our business, including but not limited to –exact locations of hunt areas, GPS

coordinates of kills, game densities, pricing of hunts, pricing of meat processing or taxidermy work, etc. The hunter(s) hereby agree to not publicly write, document or post in print, online, video or audio anything considered to be Proprietary to the hunting trip with, Cedar Ridge Outfitters without the expressed written consent of Cedar Ridge Outfitters.

11. Outfitters are licensed and required to possess the minimum level of liability insurance and acknowledge that the activities of outfitters are regulated by the Laws of Wyoming.

By signing below, the parties acknowledge that they understand all the terms of this contract, Waiver of Liability, Wounding Policy and Refund Policy and furthermore agree that this contract shall be governed by the laws of the State of Wyoming, both as to its interpretation and performance. In the case of a minor child participating in the hunt, the below signed acknowledge they are legal guardian of said minor and represent them under terms of this contract and agreements.
