# TERMS AND CONDITIONS FOR EXHIBITORS

Payment and Registration: By signing and returning the registration form included, you are agreeing to pay all fees listed by the date noted. Sharing of Exhibit Space is not allowed unless approval is requested and approved by Concord Toy and Collectable Show. Any requests of this nature must be made at the time of registration.

You also agree to the following:

Be set and ready for attendees by 10:45 am, both days. Setup times will be determined closer to the event date and information will be emailed to vendors, as we are currently trying to get early access to the venue for setup on Friday evening.

# Vendors must stay inside the boundaries marked off for your booth. You may not take up any of the walkway space. NO EXCEPTIONS!

Protection of gym floor: Because we are setting up in the gym no displays may be placed directly on the hardwood floors. This applies to tables, shelving or racking and chairs. Cardboard is an acceptable barrier for shelving and or chairs. Foam rubber pads will be provided by the organizers to be placed under all table legs. Ram-board will also be made available to any vendor that may need it.

Adult or Prohibited Material: All exhibitors must agree not to sell or distribute adult materials to minors. All materials with "Adult" content must be kept behind your table and are not to be handled by any minors. No display of any covers depicting nudity will be allowed. No adult videos or photos of any kind are allowed to be sold. All exhibitors must agree to only sell items that are NOT prohibited from being inside Concord High School.

Refund Policy: Refunds will be allowed for the full rate if requested by September 1st Any request for cancellation after September 1st, refunds will be subject to a 50% cancellation fee. No shows or cancellations after September 5th will NOT receive a refund.
