Compliance Assessments

Performing assessments / Audits / Self-evaluation against multiple frameworks and regulations using the Enactia library (or building your own template). Monitor conformity, co-ordinate your internal teams and address arising weaknesses and risks.



Record of Processing Activities (ROPAs)

Maintain a detailed Record of Processing Activity (ROPA), collaborate with all stakeholders, receive alerts and reminders, link ROPAs with Vendors via Data Transfers, perform Legitimate Interest Assessments, DPIA Pre-assessments, Capacity Assessments, maintain your Asset Register, perform Data Mapping and monitor compliance with multiple data protection laws.



Risk Management

Monitor all generated Risks, perform Risk Assessments, define your own Risk Scoring Methodology and monitor your Organization's information security posture.



Data Breach Management & Incident Registry

Maintain a detailed register of incidents, assess the exposure and the reporting to the Authorities or other third-parties and individuals, co-ordinate internal efforts, link to investigation reports and initiate reporting to Authorities, using existing or your own or regulators' templates.



Data Subject / Consumer Requests (DSR)

Record data subject requests, maintain a register of such requests, evaluate, and assess internal efforts for fulfilling the requests and monitor the conformity with the data protection law.



Data Protection Impact Assessments (DPIAs)

Perform Data Protection Impact Assessments (DPIAs) using Enactia's templates and assess the impact to individuals and the Organization from the deriving risks from a Processing Activity or a newly introduced (or about to introduced) System within the Organization.



Vendor / Third-party Management

Perform Risk Assessments to your Vendors / External Partners, identify and mitigate identified risks, link your vendors to business processes and assets, monitor the status of current contracts, and monitor data transfers and external relationships.



Document Repository

Maintain your policies, procedures in a centralised repository, link such supporting evidence and documentation with running assessments and establish categorisation and information classification.



Ticketing & Tasks

Create tasks to other Enactia Users, collaborate and coordinate all efforts towards proper governance and compliance.

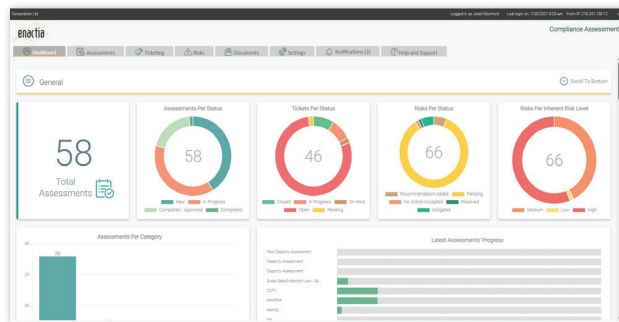


Additional optional module for Awareness & Training
