Unclaimed money is usually held up in unclaimed pay cheques, superannuation funds, insurance claims, government Departments and other places where the money has been 'abandoned', mostly without knowing that it exists.

What happens if you do not claim the money?	In most states, when the money has been unclaimed for a certain amount of time, the State Government then absorbs those funds into consolidated revenue. This means that this money is then no longer yours, and cannot be claimed back.
