5. May 1, 2021 General Election Canvass Results

Discussion: Mayor Karen Hale presented the General Election and Canvass of Election Results on this 9th day after Election Day and announce the results in accordance with the Texas Election Code, the results of the General Election conducted on May 1, 2021 Title 6, Chapter 67. Each Alderman received a copy with the notarized copy from Elections Administrator Lucy Ybarra.

- Installation of newly elected City of Plantersville Board of Aldermen (Mayor and 2 Aldermen) by Grimes County Judge Joe Fauth with Oath of Office: Mayor – Karen Hale; Aldermen Kimberly Allphin and Otis Greenwood, Jr. Certificates of Election presented.
- 7. Judge Joe Fauth presented county updates with the continued completion of the new Justice Center in Anderson. The building is now totally enclosed and weatherproof. There was a set back with the February Winter Storm and freeze, however the construction is continuing, and the project remains under budget. The new center will provide ample parking which will greatly improve the current situation for county residents doing business with the county offices.

Judge Fauth reviewed the additional access that will be available for entry and exit from both 149 and Hwy 90. The access will provide favorable traffic flow as 149 becomes congested during peak school times with elementary, jr. high and high school entrances. The Grimes County Animal Shelter had a successful fundraiser with Cause for Paws on May 1, 2021. The new shelter will be located near the new justice center and make a positive impact on the community. Construction should begin soon.

Judge Fauth concluded with the review of the upcoming election process with possible Texas redistricting after final census reports are received. It will possibly affect precincts and time frame of election primaries, etc.

8. 2021-2022 Community Development Fund, Community Development Block Grant, TxCDBG Community Development Fund: Grant requirement: Fair Housing Poster, Affidavit, Fair Housing Month Proclamation

Discussion: Mayor Hale advised that the Grant Application has been submitted to TDA and results will probably be announced in August or September according to her information.

A - Entergy: A Notice of Application for Determination of System Restoration Costs
B - Entergy filed with PUC a proceeding styled "True-up Compliance Filing for Entergy Texas,
Inc Concerning Schedule TTC (for most classes, including Residential, the proposed TTC rates provide a one-time credit (in July 2021)

Discussion: Mayor Hale presented correspondence received from Entergy regarding both items above. There is no action to be taken, this is informational documentation as filings are determined by the Public Utility Commission.

Action-Motion: None

10. Road Maintenance and Status of County Roads within City Limits

Discussion: Mayor Hale reviewed the procedure with the Intra Local Agreement in place Grimes County Road and Bridge. The repair of roads and streets with the city limits is included in this agreement and reports are to be addressed to Mayor Hale by telephone or email. Email is preferred so the issue can be documented and resolved. The GCR&B office has been very diligent in their response and referrals to Mayor Hale when requested. Mayor Hale provides initial review with photographs and description to Supervisor Walker for follow up and recommendations. This process has been in place since incorporation. Alderman Dean

remarked that if there is confusion on city roads and streets they should be renamed. Alderman Allphin advised that many roads previously did have names, however these were changed by 911 addressing with the current county road designations. Alderman Mayton expressed concern that it would be detrimental to citizens to process such a change and was unsure if that is even a possibility with 911 and postal regulations.
