## RESOLUTION NO: 53-24

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE CITY OF PLANTERSVILLE TEXAS, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE TEXAS GENERAL LAND OFFICE (GLO) FOR COMMUNITY DEVELOPMENT BLOCK GRANT – MITIGATION (CDBG-MIT) PROGRAM; AND AUTHORIZING MAYOR TO ACT AS THE CITY'S EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE CITY'S PARTICIPATION IN THE CDBG-MIT PROGRAM.

WHEREAS, The City of Plantersville desires to increase resilience to disasters and reduce or eliminate the long-term risk of loss of life, injury, damage to and loss of property, and suffering and hardship, by lessening the impact of future disasters; and

WHEREAS, The City of Plantersville desires a viable community, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low-to-moderate income;

WHEREAS, certain conditions exist which represent a threat to the public health and safety;

WHEREAS, The City of Plantersville aims to Affirmatively Further Fair Housing by identifying projects that overcome or do not increase patterns of residential segregation based on race, color, religion, national origin, sex, disability or family status;

WHEREAS, it is necessary and in the best interests of the City of Plantersville to apply for funding under the Community Development Block Grant – Mitigation (CDBG-MIT) Resilient Communities Program;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF PLANTERSVILLE, TEXAS:

- 1. That a Community Development Block Grant Mitigation (CDBG-MIT) application is hereby authorized to be filed by the City of Plantersville with the General Land Office for the recovery and mitigation efforts under the CDBG-MIT Resilient Communities Program.
- 2. That the project detailed within the application will develop, update, adopt, and implement a forward-looking Comprehensive Plans that integrates hazard mitigation planning to ensure structures built within the community can withstand future hazards
- 3. That the CDBG-MIT Application request amount be filed for up to \$200,000.00 for a comprehensive plan and zoning ordinance.
- 4. That the City Council directs and designates the Mayor as the City's Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and

the City's participation in the Community Development Block Grant – Mitigation (CDBG-MIT) Program.

5. That all funds will be used in accordance with all applicable federal, state, local and programmatic requirements including but not limited to procurement, environmental review, labor standards, real property acquisition, fair housing, civil rights requirements, and administrative requirements.
