

**ORDINANCE NO. 2026-46
AN ORDINANCE OF THE CITY OF PLANTERSVILLE, TEXAS,
ADOPTING THE FIRST AMENDMENT TO THE FY25 26 BUDGET FOR
THE CITY OF PLANTERSVILLE; AND PROVIDING AN EFFECTIVE DATE**

WHEREAS, the City of Plantersville, Texas Fiscal Year 2025-2026 Budget was adopted within the time and in the manner required by State Law; and

WHEREAS, the Board of Aldermen of Plantersville, Texas, hereby finds and determines that it is prudent to amend specific line items due to the occurrence of unforeseen situations that have impacted those line items; and

WHEREAS, the City Board of Aldermen of the City of Plantersville, Texas, further finds that the amendments, as set forth in Exhibit "A," will serve in the public interest and are necessary to support City operations; and

WHEREAS, the City Board of Aldermen of the City of Plantersville, Texas, finds and determines that the change in the Fiscal Year 2025-2026 Budget for the stated municipal purpose serves best interests of the taxpayers, is necessary, and warrants action at this time,

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF
THE CITY OF PLANTERSVILLE, TEXAS:**

SECTION 1.

That the above and foregoing premises are true and correct and are incorporated herein and made a part hereof for all purposes.

SECTION 2.

The City of Plantersville, Texas, Fiscal Year 2025-2026 Budget is hereby amended to fund the projects represented by the line items as stated in Exhibit "A." This Amendment No. 1 (Exhibit "A") to the original Adopted Budget of the City of Plantersville, Texas, for the Fiscal Year 2025-2026 shall be attached to and made part of the original Adopted Budget by the City Secretary and shall be filed in accordance with State Law. This Ordinance is hereby adopted and shall constitute the first budget amendment that has occurred since the October 1, 2025 effective date of the City's Fiscal Year 2025-2026 Budget.

SECTION 3.

That this Ordinance shall be cumulative of all other Ordinances of the City affecting the Fiscal Year 2025-2026 Budget of the City and shall not repeal any of the provisions of such Ordinances except in those instances where provisions of those Ordinances are in direct conflict with the provisions of this Ordinance; whether such Ordinances are codified or uncodified, and all other provisions of the Ordinances of the City of Plantersville, Texas, codified or uncodified, not in conflict with the provisions of this Ordinance, shall remain in full force and effect.

SECTION 4.

If any section, article, paragraph, sentence, clause, phrase, or word in this Ordinance or application thereof to any person or circumstance is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of the Ordinance, and the Board of Aldermen hereby declares it would have passed such remaining portions of the Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

SECTION 5.

The City Secretary of the City of Plantersville, Texas, is hereby directed to engross and enroll this Ordinance in the Ordinance Records of the City and to properly record this Ordinance and provide a copy to the County Clerk as required. A Board of Aldermen must amend the budget by adopting an act of "equal dignity." Tex. Att'y Gen. Op. No. GA-0431 (2006)

SECTION 6.


This Ordinance shall take effect from and after its date of passage, in accordance with law, and it is so ordained.
