a. Public comments and questions

Discussion: CDBG 2023-2024; Sophie Lehmann with Grant Works and Steve Duncan with Bleyl Engineering—Comments regarding roads and drainage: Alderman Dean questioned: 2 separate grants—who makes the final decision on recipients—MIT-MOD, Department of Agriculture (individual, committee, board—elected or appointed?) BVCOG determined project should be water/sewer/streets/roads. Alderman Kurten asked about easements—recommendation: acquire before project begins—If included with grant--land acquisition diminishes amount available to spend on actual project. When is project completion date for CDBG Grant?—late fall, 2025. MIT-MOD completion date also late fall of 2025 No specific timeline at this time. TDA has specific deadlines for each section for grant. How is money administered—reimbursement by draw request and city pays directly to contractor. CBDG is matching funds—affects points—was included in September Budget. MIT-MOD is designated \$500,000, 10% matching,

Audience Questions included how locations are determined, which is first drainage or road, how to access residents, what is median income (chart designates according to number in household and income); 51% in designated area must meet Low to Median Income (LMI) qualifications in order for area to be approved, what level of repair work will be selected (30 year or 10 year?) Residents need to be aware of surveyors asking legitimate questions—how to communicate that? if drainage not addressed first--money wasted; Post Office Road has easement issues and doesn't qualify even though one of the most heavily traveled. LMI is for 2022

Mayor Hale stated there would be called meetings once the surveys are completed.
