Regular Meeting Minutes—City of Plantersville July 17, 2023

- 1. Call to Order: Quorum established. Mayor Hale called the meeting to order at 7:00 p.m. The invocation was given by Alderman Otis Greenwood with pledges led by Mayor Hale.
- 2. Minutes, June 12, 2023

Motion to Approve: Alderman Allphin

Second: Alderman Kurten Voting: Yes: Unanimous

Final Resolution: Motion carries

- 3. Public Comments: John Nicks questioned why he had to adhere to 8' distance required for media—stated he is not connected to media.
- 4. Chamber of Commerce Visit/presentation: Chamber "Pop-In" visit, effort to have constant connection with community and government. Chamber Executive Director, Lucy Ybarra presented Mayor Hale with gift from Washington on the Brazos and board with a small bag of goodies. Ybarra stated it is an effort to show support for all communities.

Discussion: Mayor Hale reviewed the invoices which were sent to all Alderman.

- 6. Discuss/consider/approve: review road repair reports/estimates on suggested repairs for Post Office Road **Discussion:** Kim spoke with contact and will have estimate at next meeting. Mayor Hale received estimate/quote from Eubank. Basically, all existing asphalt needs to be torn out and begin with new materials, etc. Estimate was \$38,450 with other fees as required. Item was for discussion only; other quotes needed at next meeting.
- 7. Discuss/consider/approve: City Procedure for Motions.: See 3.8 in City of Plantersville Rules of Procedure and Robert's Rules of Order: at Alderman Dean's request. Mayor Hale read the referenced section and asked if that answered Alderman Dean's concerns. He replied in the affirmative. Discussion, no action taken.
- 8. Discuss/consider/approve: City procedure for having the City Attorney present at meetings: at Alderman Dean's request.

Discussion: The Attorney sent a Resolution recommendation which was sent to everyone. Alderman Dean said "does everyone understand what he writes"? Alderman Kurten agreed with Alderman Dean that she did not understand what he writes and we need have him at every meeting. Alderman Allphin questioned is having attorney present each time necessary and feasible? Mayor Hale requested that Alderman Dean

submit his request in writing to her. Alderman Allphin questioned having a brief attached with each Resolution. Kurten said "have him here at every meeting"—Alderman Bettes stated not good use of city funds. Alderman Allphin suggested we should try to have neutral ground. Discussion continued...Mayor Hale repeated that Attorney's comments are his thoughts the legality of a matter. If the Resolution is more in depth, perhaps explanation is needed. Alderman Dean stated he was through with issue.

Alderman Kurten moved to postpone Resolution 40-23: A Resolution of the City pf Plantersville, Texas, adopting a policy regarding the attendance of Legal counsel at Board of Alderman meetings.

10. Discuss/consider/approve: GLO CBDG MIT MOD - Old Schoolhouse Road Project

Discussion: Mayor Hale stated the GrantWorks survey crew has completed the MIT MOD survey results. Mayor has signed it. When the grant application is completed, a Public Notice will be posted to give notice that anyone can read the application.

11. Discuss/consider/approve: Treats on a Dirt Street

Discussion: Positive response in the past. Alderman Allphin proposed we host event on Thursday, October 26, 2023 with a budget not to exceed \$1,000.

She asked for approval from PTH Board to use a vacant closet with a lock on it on the second floor of the PTH building and received approval pending a decision by the City Board of Alderman.
