6. Discuss/consider: TxDOT project SH249/FM1774 and/or project SH105/FM1774 update
7. Discuss/consider/approve: requested Plantersville Cemetery sign or signs on FM 1774
8. Discuss/consider/approve: actions required to order/conduct May, 2020 election of officers
9. Discuss/consider/approve: ID cards for Board Members that are on the current 2 year term

12. **Enter into Executive Session/closed meeting, if needed.** If, during the course of the meeting and discussion of any items covered by this notice, the Board determines that a Closed or Executive Session is required, then such closed meeting will be held as authorized by Texas Government Code, Chapter 551, Sections 551.071 -consultation with counsel on legal matters; 551.072 – deliberation regarding purchase, exchange, lease of real property; 551.073 – deliberation regarding a prospective gift; 551.074 – personnel matters regarding the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; 551.076 – implementation of security personnel or devices; 551.087 – deliberation regarding economic development negotiation; 551.089 deliberation regarding security devices or security audits; and/or other matters as authorized under the Texas Government Code. If a Closed or Executive session is held in accordance with the Texas Government Code as set out above, the Board will reconvene in Open Session in order to take action, if necessary, on the items addressed during Executive Session.
