Speakers will be recognized in the order in which the Mayor receives the required form. Remarks will be limited to 2 minutes each. Public Comments are limited to 20 minutes. Board responses are limited to recitation of existing policy or statement of specific factual information given in response to the inquiry. Any deliberation or decision by the Board shall be limited to a proposal to place the subject on the agenda of a future meeting. Any further discussion is prohibited. **Unless specifically questioned, the public will have no further discourse with the Board. LGC 551.042**
Notice: any person(s) causing disruption or using profane, abusive, or threatening language may result in removal from the Meeting.
3. The City of Plantersville will hold Public Hearing with Mayor Allphin providing the 2025-2026 FY Budget Cover Announcement, Proposed Budget FY 2025-2026 review and provide additional copies of the Proposed FY 2025-2026 Budget copies for interested citizens.

5. Following the Public Hearing on Proposed Budget for the City of Plantersville, the hearing will be closed with announcement from Mayor Allphin.
6. The Board of Aldermen will consider and may act upon adoption of the proposed budget for the City of Plantersville Fiscal Year 2025-2026.
7. Board update/discussion. Items of community interest (no action may be discussed, except to put on an agenda)
8. **Closed Session**
The Aldermen may meet in closed session pursuant to the Texas Government Code Chapter 551
9. **Open Session**
Return to open meeting: take action on items discussed in closed session

***The Board of Aldermen of the City of Plantersville reserves the right to adjourn into Executive/Closed Session at any time during this public hearing meeting to discuss any of the matters listed above as authorized by Chapter 551 of the Texas Government Code: Section 551.071 – §551.071(Consultation with Attorney), §551.072 (Deliberations about Real Property), §551.073 (Deliberations about Gifts and Donations), §551.074 (Personnel Matters; to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear a complaint or charge against an officer or employee.), §551.076 (Deliberations about Security Devices or Personnel), and §551.087 (Deliberation about Economic Development Negotiations). If an Executive/Closed Session is held in accordance with the Texas Government Code as set out above, the Board of Aldermen will reconvene in Open Session in order to take action, if necessary, on the items addressed during Executive Session.
