ITEMS ACCEPTED & QUALITY STANDARDS

- Ensure that all clothing is clean, wrinkle free and is freshly laundered. We will not accept items that smell like smoke or have pet hair on them. The better they look the more you will make!
- Ensure that all clothing is "gently used" and ready to sell (floor ready): that is free of stains, snags, rips, tears, worn out knees, fading, peeling, missing buttons, broken zippers, torn seams, etc. Clothes must be brought in hanging, lying flat or folded neatly in tote or basket.
- Toys, equipment, and furniture must include original parts, be clean, and in good working condition. Batteries must be included in toys that need them.
- Ensure that all clothing is fashionable and season appropriate. If your items are deemed unseasonable or inappropriate, they will be returned to you as a "No Thank You". Please don't take the NTY'S personally. We at *Cool Kids Consignment* are professionals and will not accept items that we don't feel we would be able to sell for you. We reserve the right to donate or dispose of any item at anytime that we can not sell without notifying the consignor.
- We accept children's clothing in sizes newborn through size 14, Women's clothing to size 3X, formal wear, designer purses, furniture, baby equipment, and fine jewelry.
- Clothing with defaced or missing tags will be consigned at a lower price.
- All furniture and equipment must meet current safety standards.
- We do not accept breast pumps, underwear, diaper genies, stuffed animals, car seats, toys with small parts, or recalled items for safety and sanitary reasons.
- *Cool Kids Consignment* will not be accepting consignment during this time.
- Consignor is responsible for bringing any toys or items into this store with lead content higher than the health department deems safe, and will accept any fines leading to the item.

COMMISSION

- *Cool Kids Consignment* will determine the selling price of each item and has the right to reduce or change the price at any time during the consignment period.
- Consignors will receive 40% of the final sale price and 50% - 60% for High-Dollar items. Consignors account money can be used at anytime for in-store purchases. Payouts can be received at anytime.
- The person who opened the account is the only person who can pick up any money balance or use consignor credit.
- Consignor's items will be priced at the discretion of *Cool Kids Consignment* owner/management.

CONSIGNMENT PERIOD

- Items accepted for consignment will be displayed for 60 days from the date they are placed on the floor for sale.
- Items will be placed on the floor as space becomes available, in the order they were received. (Large consignment might be split up to give other consignors floor space.)
- A \$5.00 service charge will be assessed for early removal of "high-ticket" items.

TERMS OF CONSIGNMENT

- All items are left at the consignors' risk. *Cool Kids Consignment* shall not be held responsible for any loss due to fire, water damage, or theft to merchandise.
- We will donate all non-consigned / unacceptable items to charity.

RECLAIM (UNSOLD ITEMS)

- At the end of the 60-day consignment period, Consignors are responsible for claiming the "high-ticket" items that have not sold. It is the consignor's responsibility to locate and pull reclaimed items from the sales floor.
- Consignor must pick up all unsold "high-ticket" items within one week (7 days) after the closing date of the contract. All "high-ticket" items not picked up after 7 days will become property of *Cool Kids Consignment*.
- Any unsold, abandoned, or expired merchandise will become property of *Cool Kids Consignment*. **Inactive accounts forfeit any moneys in the account after 90 Days.**
