

## Welcome to Engineers R Us

These Terms & Conditions apply to my Engineering After School, Lunchtime, Workshops, Online and all other services provided by Mr G Campetti trading as Engineers R Us (Mr G Campetti). We would advise you to read these carefully before booking. The following Terms and Conditions will apply between you and Mr G Campetti and do not affect your statutory rights. Your continued use of the services constitutes acceptance of these Terms and Conditions.

### **After School and Lunchtime.**

- Fees for After School and Lunchtime are termly and are booked for and paid for via my online booking system as included on my website.
- All fees are non-refundable once payment has been made. Any refunds are at the discretion of Mr G Campetti.
- Any After School and Lunchtime club that is booked and where a session is missed due to illness or school or out of school activities, commitments or trips a session cannot be made up on any other dates nor can missed sessions be refunded. Any refunds are at the discretion of Mr G Campetti.
- Mr G Campetti reserves the right to cancel or change an After School and Lunchtime session at short notice and will contact you if this need arises. In the event that we need to cancel or move a session, you will be entitled to a refund.
- A minimum number of attendees are required for After School and Lunchtime clubs to run. We will endeavour to notify you as soon as possible if a club needs to be rescheduled or cancelled due to low numbers and will offer a refund where necessary.
- Mr G Campetti requires good behaviour to allow all children to participate and reserves the right of exclusion should behaviour be unacceptable to Mr G Campetti.
- If your child has one to one support at school, I cannot offer that support during my club or tailor any of my sessions/activities to meet any specific needs the child may have. If the parents/guardians would like their child to attend the club, then the parents/guardians of the child must discuss and agree with the school and Mr G Campetti how the appropriate support will be provided for the child during the club. Any acceptance is at the discretion of Mr G Campetti trading as Engineers R Us.
- Your child must be collected at the club finish time. If your child is collected later than the club finish time then a late pickup fee of 1 full session cost may be applied and is payable to Mr G Campetti within 48hrs. If late pickup fee is not paid when due, or further late collection occurs, then your child will not be allowed to attend the club any further and the remainder of the term's fees will be forfeited.

### **Workshops.**

- Fees for Workshops are to be paid in full within 14 days of date shown on the invoice as submitted by Mr G Campetti. Failure to make full payment within 14 days could result in the Workshop not taking place.
- Full payment to be made via electronic bank transfer to the account specified by Mr G Campetti.
- All fees are non-refundable once payment has been made. Any refunds are at the discretion of Mr G Campetti.
- We reserve the right to cancel or change a Workshop date at short notice and will contact you if this need arises. In the event that we cancel or move a session, you will be entitled to a full refund.
- Mr G Campetti requires good behaviour to allow all children to participate and reserves the right of exclusion should behaviour be unacceptable to Mr G Campetti.
