<b>LIMITED WARRANTY</b>	

ThinTanks USA ("Company") headquartered in Conroe, TX 77385, warrants that all products sold by ThinTanks USA ("Products") will be free from defects in materials and workmanship under normal use and service for a period of one (1) year from the date of original shipment. This Limited Warranty is provided to the original purchaser ("Buyer"), non-transferable, and applies solely to products sold and located within the USA.

#### 1. Warranty Coverage

If a defect in materials or workmanship is discovered within the warranty period, the Company will, at its discretion, either:

- 1.1 Replace the defective product, or
- 1.2 Repair the defective product at no charge to the Buyer.

#### 2. Exclusions

This Limited Warranty does not cover:

- 2.1 Damage caused by improper installation, misuse, abuse, or neglect of the product.
- 2.2 Damage resulting from unauthorized modifications or alterations to the product.
- 2.3 Damage due to adverse conditions, chemicals, foreign materials, or environmental factors beyond the Company's control.
- 2.4 Incidental, special, or consequential damages, including but not limited to, lost profits or the cost of repairing or replacing other property.
- 2.5 Costs associated with labor, delays, vandalism, negligence, or fouling by foreign materials.

#### 3. Warranty Voidance

The warranty will be voided by any of the following actions:

- 3.1 Abuse, misuse, or misapplication of the product.
- 3.2 Improper installation or maintenance.
- 3.3 Unauthorized alterations or repairs.

#### 4. Limitations

Some states do not allow limitations on the duration of implied warranties or the exclusion or limitation of incidental or consequential damages. Therefore, the above limitations may not apply to the Buyer. This Limited Warranty gives the Buyer specific legal rights, and Buyer may have other rights which vary from state to state. Consult applicable state laws to determine Buyer's rights.

#### 5. Implied Warranties

To the extent consistent with applicable state law, any implied warranties that cannot be disclaimed, including the implied warranties of merchantability and fitness for a particular purpose, are limited to one (1) year from the date of original shipment.

#### 6. Claim Procedure

To make a warranty claim, the Buyer must:

- 6.2 Submit the completed Warranty Claim Form, proof of purchase, and any requested photographic evidence to ThinTanks USA.
- 6.3 Allow ThinTanks USA or its authorized representatives to inspect the tank if necessary.
