LAKE CONROE LAKE LEVEL

[WHERE HAS ALL THE WATER GONE]

According to the San Jacinto River Authority, working in conjunction with Houston Public Works

LAKE CONROE'S WATER LEVEL WILL BE REDUCED AND MAINTAINED TO 200 FEET ABOVE MEAN SEA LEVEL, OR BY 1 FOOT, FROM APRIL 1 TO MAY 31, AND TO 199 FEET ABOVE MEAN SEA LEVEL, OR BY 2 FEET, FROM AUG. 1 TO SEPT. 30.

and Coastal Water Authority, in a press release from July 30th, Lake Conroe's water level was reduced 1 foot, from April 1st to May 31st. Beginning Aug. 1st and continuing to Sept. 30th the lake will be lowered an additional 2 feet putting it at 199 feet above mean sea level. In case you were wondering why the City of Houston has a vote in our water level, they own two-thirds of the drinking water in Lake Conroe. The

other government entity with authority on this matter is the Texas Commission on Environmental Quality which is the State level entity that regulates how much drinking water can be released annually from water supply reservoirs like Lake Conroe and Lake Houston. Below is a visual of what the loss of 2 feet will look like in some places for Lake Conroe...

This action is labeled a "temporary" and was based on the U.S. Army Corp Of Engineers dredging project downstream of Lake Conroe. Let's all keep this "action" on our radar because that dredging project is due to complete in the Spring of 2019 and we will be wanting our water back at that point!
